The following is to be added at the beginning of Article III of the original articles of incorporation: This corporation is organized exclusively for charitable, cultural and educational purposes within the meaning of the Internal Revenue Code Section 501(e)(3), namely; to raise awareness within the American Dominican community and the general community about the unique outture, history, philosophy, arts, religion, spirituality, music, literature, foods and traditions of the Dominican Repblic, its peoples, families and communities. It will plan and implement classes, courses, exhibitions, social gatherings, and all manner of events to help Dominicans identify positively with their communities and their history. thereby protecting the community against deterioration and climinating prejudice and discrimination. It is empowered to carry out any intervention to assist needy persons or families in avoiding crises, attaining better standards of living and increasing hopefulness for the future. This corporation will not attempt to influence legislation or participate in political campaigns. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to its directors, officers or to any private person except that this corporation will be empowered to pay reasonable compensation for services rendered, work done, resources purchased or or properties acquired that are seen by the direct to be in furtherance of its exempt purposes. Upon the filing of these articles of incorporation, the Directors will be empowered to adopt bylaws and other related documents, to appoint corporate officers, to open bank accounts, and empowered to adopt bylaws and other related documents, to appoint corporate officers, and take any other manner of action required for the operation of this corporation. The Directors may perform these actions through in person meetings. meetings via electronic media, through signed written consent, including virtual signatures. Any manner through which clear communication of a director's intentions may be expressed shall be the equivalent of a vote east at a meeting. Replies from emails belonging to the directors will be seen as the equivalent of vote cast at a meeting concerning the action detailed in the email which is being responded to. In the event of this corporation's dissolution, the directors will -after clearing all debts and liabilities— distribute any remaining funds or assets to other charitable organizations recognized by the IRS under section 501(c)(3) that have similar purposes to those of this corporation.
