Articles of Amendment for Nonprofit Corporation Ferris Family Foundation Inc.

Exhibit A

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof.

No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

Notwithstanding any other provisions of this document, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code ("IRC") or corresponding section of any future tax code, or by an organization, contributions to which are deductible under Section 170(c)(2) of the IRC, or corresponding section of any future tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

The corporation will distribute its income for each tax year at a time and in a manner as not to become subject to the tax on undistributed income imposed by Section 4942 of the IRC, or the corresponding section of any future federal tax code.

The corporation will not engage in any act of self-dealing as defined in Section 4941(d) of the IRC, or the corresponding section of any future federal tax code.

The corporation will not retain any excess business holdings as defined in Section $49\overline{43}(c)$ of the IRC, or the corresponding section of any future federal tax code.

The corporation will not make any investments in a manner as to subject it to tax under Section 4944 of the IRC, or the corresponding section of any future federal tax code.

The corporation will not make any taxable expenditures as defined in Section 4945 of the IRC, or the corresponding section of any future federal tax code.
