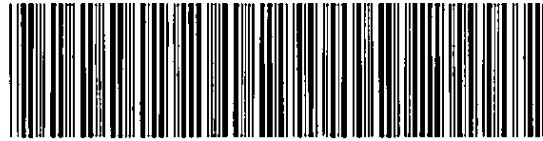

**Articles of Incorporation of Falcon Baseball Club of Dunedin Inc.**

*In compliance with Chapter 617, F.S. (Not for Profit)*

The undersigned, for the purpose of forming a corporation not-for-profit pursuant to Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

**Article I**

Name

The name of this corporation shall be Falcon Baseball Club of Dunedin Inc.

**Article II**

Principal Office

**Article III**

Purpose

The purpose for which the corporation is organized is exclusively for charitable purposes and amateur sports competition, furthering the skill, team building, sportsmanship, and athleticism of high school aged youths involved with the sport of baseball in Dunedin, Florida, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, and this exclusivity of purpose also includes to receive, hold, invest, and administer property and to make expenditures for the benefit of youth baseball players in Dunedin, Florida.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
