The undersigned subscribes to these Articles of Incorporation for the purpose of forming a corporation not-for-profit pursuant to the provisions of the Florida Not for Profit Corporation Act. Chapter 617, Florida Statutes.

#### ARTICLE I

#### Name, Street Address and Mailing Address

The name of the corporation shall be "Motorcycle Political Action Committee, Inc." The principal street and mailing address of the corporation is: 201 South Orange Avenue, Suite 1500, Orlando, Florida 32801.

#### ARTICLE II

Duration

This corporation shall have perpetual existence.

## ARTICLE III Purpose

The primary purpose for which this corporation is created and maintained shall be to conduct political activities as a "political organization." including the support of and opposition to state and local candidates, and to conduct one or more activities permitted under Section 527 of the Internal Revenue Code of 1986, as amended, and the Florida Election Code.

#### ARTICLE IV

#### Registered Office and Agent

ARTICLE V

Board of Directors

The corporation shall have at least three directors. The manner in which the directors are

elected or appointed shall be as provided in the bylaws; provided, however, that the incorporator

will appoint the initial directors.

There shall be no limit on the number of terms a Board member may serve unless provided

otherwise in the by-laws. The term of office of Board members shall be stated in the by-laws. The

Board of Directors may authorize reimbursement of expenses incurred by Board members in

conjunction with the corporation's business or other approved activities directly related to the

corporation's purposes.

Nothing herein shall be construed to preclude any Director from serving the corporation in

any other capacity and receiving additional compensation therefore.
