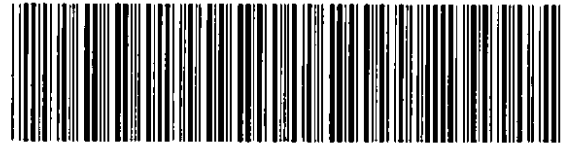

**Articles of Incorporation of the  
Home Education Enrichment Day, Inc.**

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States,  
desiring to form a Nonprofit Corporation under the NonProfit  
Corporation Law of Florida, and in compliance with Chapter 617, F.S., do hereby certify:

**ARTICLE I NAME**

The name of the Corporation shall be **Home Education Enrichment Day, Inc.**

**ARTICLE II LOCATION**

The principal street address where the office of the Corporation is to be located is  
7500 East Country Club Road, Boca Raton, Florida

**ARTICLE III PURPOSE**

**Home Education Enrichment Day, Inc.** is organized to serve God by assisting families in their call to  
home educate their children.

**Home Education Enrichment Day, Inc.** is organized exclusively for educational and religious purposes,  
including, for such purposes, the making of distributions to organizations that qualify as exempt  
organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of  
any future federal tax code. The corporation does not contemplate pecuniary gain or profit, incidental  
or otherwise.

**ARTICLE IV MANNER OF ELECTION**

The bylaws shall contain provisions relating to the board of directors of the corporation, including, but  
not limited to the number of directors, the manner of their election or appointment, qualifications, term  
of office, manner of filling vacancies, and any other provisions which may be desired and which are not  
in conflict with statute or these Articles of Incorporation. The number of directors may be increased or  
decreased from time to time as may be determined by the board of directors, but shall never be less  
than 4.

#### ARTICLE IX LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Three hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

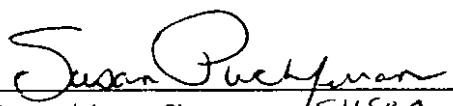
#### ARTICLE X PERSONAL LIABILITY

No officer or director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the officers or directors be subject to the payment of the debts or obligations of this corporation.

#### ARTICLE XI DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
