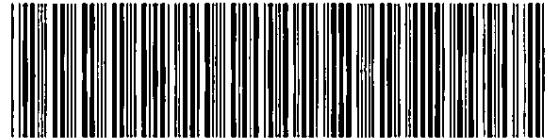

Articles of Incorporation for Presume Competence Academy, Inc.

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I. NAME

The name of the Corporation Not for Profit shall be Presume Competence Academy, Inc.

ARTICLE II. PRINCIPAL OFFICE & MAILING ADDRESS

The principal office and mailing address of the Corporation shall be: 918 Drew St., Clearwater, FL 33755, or at such other place as may be designated, from time to time, by the Board of Directors.

ARTICLE III. DURATION/PURPOSES OF THE CORPORATION

- A. The period of duration of the corporation is perpetual.
- B. The purpose of said corporation is exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Within the scope of the foregoing purposes, and not by way of limitation thereof, the Corporation is specifically dedicated to operating a private school to serve students with disabilities in the State of Florida.
- C. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2)

of the Internal Revenue Code, or the corresponding section of any future federal tax code.

ARTICLE IV. DISSOLUTION OF THE CORPORATION

- A. Upon the dissolution of the corporation, after paying or making provisions for the payment of all the legal liabilities of the corporation under Florida Law, any assets lawfully available for distribution shall be distributed to one (1) or more qualifying organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986 (or described in any corresponding provision of any successor statute) which organization or organizations have a charitable purpose which, at least generally, includes a purpose similar to the terminating or dissolving corporation.
- B. The organization to receive the assets of the Presume Competence Academy, Inc. (PCA) hereunder shall be selected by the discretion of a majority of the Directors of the PCA and if its Directors cannot so agree, then the recipient organization shall be selected pursuant to a verified petition in equity filed in a court of proper jurisdiction against the PCA by one (1) or more of its managing body which verified petition shall contain such statements as reasonably indicate the applicability of this section. The court upon a finding that this section is applicable shall select the qualifying organization or organizations to receive the assets to be distributed, giving preference if practicable to organizations located within the State of Florida.

ARTICLE V. SELECTION OF CORPORATE DIRECTORS

The Directors of the Corporation shall be selected in accordance with methods and qualifications specified in the Bylaws of the Corporation when adopted. The initial Directors shall be as designated below and serve for a term of 2 years. In no event shall the number of directors be fewer than three.
