

Articles of Incorporation

Florida Not for Profit Corporation

The undersigned hereby adopts the following articles of incorporation in Compliance with Chapter 617, F.S., (Not for Profit).

Article 1 Name

The name of this corporation shall be Hola Orlando Community Center, Inc.

Article 2 Principal Office

Article 3 Purpose
