- My name is Robert J Jones Jr, I am presently 69 years old, and my current address of residence is 6195 9th Avenue Cir NE, Bradenton, Florida 34212.
- The purpose of this Affidavit is to affirm that I am an officer of RV7 Inc. and certify that this document is true and correct. I am an owner and have approval of the corporation to cancel the old corporation and create a new corporation with the same business name.
- On April 14, 2022, we filed with SunBiz for RV7 Inc as a FOR-PROFIT corporation, Document Number P22000032399.
  This was a mistake that we did not learn about until recently notified by Sarasota Airport. We should have filed as NOT-FOR-PROFIT.

On September 17, 2023, I filed for a Dissolution of the Corporation RV7 Inc, Local Reference ID 300415860633. We will not be filing with this configuration again, and it may be removed from your system.

On September 18, 2023, I filed a new request with SUNBIZ for a NOT-FOR-PROFIT corporation with the same name, RV7 INC, Local Reference ID 600415935956 NEW.

We are only following this path with the same business name as it was a mistake to file as a FOR-PROFIT organization, and to avoid changing banking accounts and re-registering our airplane with the FAA.

On September 19, 2023, I received your rejection of the new filing. As we will no longer be using the old registration, and we are the same corporation, we would like to file correctly with same corporation name.

I called SUNBIZ on September 20, 2023, via phone, and was told I need to file this Affidavit to make this happen.

Please advise if I need to follow-up with any additional actions.
