

Adding: Article IX Dedication of Assets

The property of this corporation is irrevocably dedicated to educational and charitable purposes as defined under

Section 501(c)(3) of the Internal Revenue Code and no part of the Net Income or Assets of this Corporation shall ever inure

the benefit of any director, officer or member thereof, or to the benefit of any private individual or corporation.

Adding: Article X Dissolution Clause

Upon the dissolution of this organization, Assets shall be distributed for one or more exempt purposes within the meaning of Sections 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code, or shall be distributed to the Federal Government, or to a State or Local Government, for a public purpose. No part of the assets of the Organization shall inure to the benefit of, or be distributable to its directors, officers, or private persons or corporations.

Adding: Article XI Additional Provisions

Notwithstanding any other provisions of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax Code under the Code Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal Tax Code. The corporation is Organized exclusively for charitable, education, and scientific puposes, including for such purposes, the making of distribution to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal Tax Code. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
