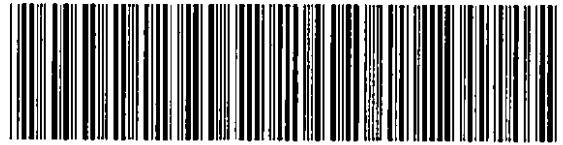

ARTICLE I.-NAME

The name of this corporation is THE HARRIS BRAND FOUNDATION, INC.
