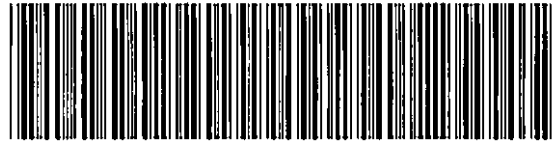

**I**

The name of the corporation shall be **HENDERSON CROSSING HOMEOWNERS' ASSOCIATION, INC.**

**II**

The duration of the corporation shall be perpetual.

**III**

The purpose for which the corporation is organized is to provide for the preservation of the values, amenities, attractiveness and desirability of real property known as **HENDERSON CROSSING** located in Leon County Florida including but not limited to the maintenance of the stormwater management facility located on the property.

**IV**

In the event of dissolution of the corporation, the assets shall be dedicated to a public body or conveyed to a non-profit organization with similar purposes.


## XI
