

**ARTICLES OF AMENDMENT TO THE ARTICLES OF
INCORPORATION
FOR
JESUS CHRIST MINISTRIES GLOBAL, INCORPORATED**
(a corporation not for profit)
(Document Number N23000011711)

Pursuant to the provisions of Florida Not For Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation.

1. The name of the corporation is JESUS CHRIST MINISTRIES GLOBAL, INCORPORATED.

2. Pursuant to Section 617.1002, Florida Statutes, the following Amendments have been approved and adopted by a majority vote made by the corporation's members entitled to vote on such matters, at a meeting called for that specific purpose:

ARTICLE III is hereby amended to add the following to the end of said Article III:

Said corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations under Section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code).

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or the corresponding section of any future Federal tax code).


Upon the dissolution of this corporation assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code

(or the corresponding section of any future Federal tax code), or shall be distributed to the Federal government or to a state or local government for a public purpose.

3. The remaining Articles of Incorporation for JESUS CHRIST MINISTRIES GLOBAL, INCORPORATED, shall be unchanged and shall remain in full force and effect. ^{1/8 8/20/24}

The said Amendment was adopted on August 20, 2024 by a majority of the members entitled to vote on such matters.
