I would like to dissolve old Non-Profit Corporation and start a new one.

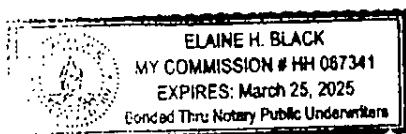
