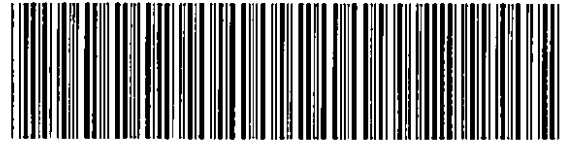

**ARTICLES OF INCORPORATION
FOR
YOUTH BRIDGE COMMUNITY INC.**

The undersigned incorporator, for the purpose of forming a Florida not-for-profit corporation, hereby adopts the following Articles of Incorporation:

Article I

The name of the corporation is Youth Bridge Community Inc.

Article II

The principal place of business address is: 915 Henry Street, Punta Gorda, Florida 33950. The mailing address of the corporation is: 915 Henry Street, Punta Gorda, Florida 33950

Article III

The specific purpose for which this corporation is organized is: To prepare at-risk youth who age out of the State welfare system, to become self-sufficient with life skills, through engagement in local community projects. The corporation is organized exclusively for charitable purposes. Such activities are within the meaning of Section 501(c)(3) of the Internal Revenue law. Notwithstanding any other provision of these articles, this corporation shall not engage in any activities or exercise in any powers that are not in furtherance of the purpose of this corporation. This corporation shall not carry on any other activities not permitted by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code. No substantial part of the activities of this corporation shall consist of lobbying or propaganda, or otherwise attempting to influence legislation.

Article IV

The manner in which Directors and Officers are elected or appointed is provided for in the ByLaws.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

Article VII

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code, or shall be distributed to either such organization organized and operated exclusively for public and charitable purposes, which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.
