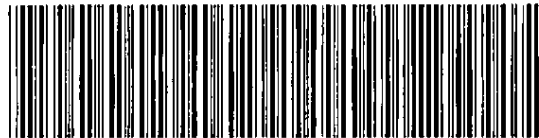

CHARTER
OR
ARTICLES OF INCORPORATION
OF
Iglesia Evangélica y Misionera
León De La Tribu de Juda, Inc.

(NOT FOR PROFIT)

We the Undersigned personal of state Florida all of whom are of legal age, each being competent to contract hereby from ourselves and our successor into a corporation not for profit under the Law of the State of Florida, and adopt the following Articles of Incorporation.

ARTICLE I NAME

The name of this corporation shall be: Iglesia Evangélica y Misionera León De La Tribu de Juda, Inc

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 7999 Harbor Bend Circle
Orlando Florida 32822 Country of Orange, State Florida.

ARTICLE III PURPOSES

The purposes for which the religious organization will be formed: I be: Iglesia Evangelica y Misionera León De La Tribu de Juda, Inc.

Will be the following: (a) Establish a Church or Churches to promote, instruct and establish the teachings of Jesus Christ and to facilitate Christian worship and fellowship among members, non-members, and the general public.
(b) Facilitate, implement and support religious Missionary and Evangelistic work, locally and internationally.
(c) Train, prepare and Ordain Ministers, Missionaries, Evangelists, Preachers, Religious Workers, Bible Teachers, Counselors, Elders, Deacons, Volunteer Chaplains for Christian service to the Church and the Community.
(d) Establish an association or convention of the local church and future branches.
(e) Establish theological institutes, seminaries of ministers, and other institutions of learning for the continuing religious education of local, national, and international members, as well as the community at large.
(f) Establish Mission Houses for people, Community Centers for the poor, Drug and Alcohol Rehabilitation Centers, and Youth Centers.
(g) Use all means to communicate Christian instructions, meditation, and principles to members and the general public, in accordance with appropriate copyright statutes. Promote and exercise the constitutional rights of freedom of expression, religion and press in each and every one of the religious activities, in due form in accordance with the law.
(h) Notwithstanding any other provision of these articles, the organization is organized exclusively for one or more of the purposes specified in section 501(c)(3) of the Internal Revenue Code of 1986, and will not carry on any activity that is not permitted to be performed by an organization exempt from federal income tax under IRC 501(c)(3) or corresponding provision of any subsequent tax law
(I) No material part of the organization's activities will be based on propaganda, nor will it attempt to influence legislation (except as otherwise provided by the IRS 501(h)), or participate or intervene in (including the publication or distribution of this of statements), any political campaign on behalf of or in opposition to any candidates for public office.

(In the event of dissolution, al of the remaining assets and property of the organization shall after the payment of necessary expenses therefore distributed to such other organization as shall qualify under section 501(c)(3) of the Internal Revenue Code of 1986 or Corresponding provisions of any subsequent Federal Tax Law, or to the Federal Government, or State or Local Government for public purpose subject to the approval of a justice of the Supreme Court Of State Florida.

ARTICLE IV POWERS

Iglesia Evangélica y Misionera León De La Tribu de Juda, Inc. Will and exercised all the rights and powers conferred on corporations under the laws of the State of Florida, provided that this corporation has no authority to engage in any activity other than to advance objects and purposes set forth in Article III.

ARTICLE V NO FINANCIAL PROFIT OR MONETARY GAIN

Iglesia Evangélica y Misionera León De La Tribu de Juda, Inc. is not organized, or be operated for profit or pecuniary gain, and includes the distribution of goods, or dividends to members, as this organization are formed non-profit. The property, assets, and net earnings of this corporation are irrevocably dedicated to religious, scientific and charitable and any gain or net inflow of this corporation shall be to the advantage or benefit of any director, officer, and member or for the benefit of private shareholders or individuals. With the dissolution or closing liabilities of the corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for religious, charitable, scientific or which has established its tax exempt status under Section 23701 (d) of the Code of Internal Taxes. If this corporation has any assets in deposits, such property shall be distributed according to the decrees of the Superior Court of the County within which the principal office of this corporation is located, at the request for that at the attorney general or by any person interested in the settlement.

ARTICLE VI LIMITATION OF ACTIVITIES

Iglesia Evangélica y Misionera León De La Tribu de Juda, Inc. AI Did not conduct propaganda as a substantial part of its activities, or attempt in any way influence the legislation. This corporation shall not participate in or intervene in (including publishing or distributing of statements) any political campaign on behalf of any candidate for public office.

ARTICLE VII DIRECTORS / OFFICERS MANNER OF ELECTION

The officers in charge of managing the affairs of this corporation shall be as follows: President (Pastor) Secretary, Treasurer and the Deacons. The President shall be appointed by Iglesia Evangélica y Misionera León De La Tribu de Judas, Inc. The president shall hold office until otherwise directed by the above mention councils. The secretary, treasurer, and deacons shall be elected by due process of general election. Candidates shall be selected from among the members of the corporation who qualifies for election as designated by the corporation's bylaws. Elections are to be held annually and every active member of the corporation has the right to vote. One the persons to hold these positions have been elected by vote majority, they shall hold office until their new successor has been elected and qualified.

ARTICLE XI MEMBERSHIP

Membership shall be open to anyone willing to comply with the corporation bylaw, however, neither the incorporates nor the members shall have any vested right, interest, or privilege of, in or assets function, affair or franchises of this corporation, or any right, interest or privilege which may be inheritable, or shall continue after his/she membership ceases in the forenamed corporation. The corporation shall not have the power to buy, mortgage sell encumber of deed or dispose of any property which it may acquire, without the consent or the direction of two-thirds (2/3) majority vote of the members, or its successors. The President shall sign and the secretary shall attest all legal contracts authorized by the members of this corporation and of the State of Florida.

ARTICLE XII PROPERTY

The Corporation shall have the power to buy, acquire, and hold title in fee simple, in trust, or otherwise to both real and personal property, and improve, encumber, sell convey and dispose of such property, to borrow money, execute note bonds and other evidences of indebtedness and to secure the same by mortgage and deeds of trust, annuity bonds, and other instruments of indebtedness and to pay interest thereon, to improve, adapt and use property held by it for, the said corporation or the income there from in the religious, education, benevolent, or social activities of the said corporation without financial profit to its members except as may be necessary in the payment of salaries, or other compensation for service rendered, and the corporation shall have the power to erect and to build and maintain residence for the use and occupancy of the ministers of the said corporation, not for profit under the laws of the State of Florida




