The mission of The Community Achievement and Mentoring Program, Inc. (CAMP) is to empower children and young adults to become well eductated, responsible, self-directed, think critically and creatively, embrace their self-worth, develop a commitment to social justice and to reinforce education as knowledge learned and shared.

The ultimate goal is to liberate the mind, heart and spirit of children and adults through mentoring, role modeling programs and other services. This will be done by assisting the community with spiritual growth, developing confidence and reaching for higher educational endeavors. This will be done by providing one-on-one mentoring programs, facilitating weekly and monthly workshops and seminars that will deal with self-identity, physical and mental safety, establishing and knowing self-worth, career development and college preparation. There will also be quarterly and yearly programs that will encourage sport activities such as basketball tournaments, football training and all sporting areas that will encourage wellness and opportunities professional recruting for college.

CAMP is organized exclusively for charitable, religious, educational, literary and scientific purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corporation provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from federal Income Tax under Section 501(c)(3) of the internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

In the event of dissolution, the assets of the organization will be turned over to one or more organizations which themselves are exempt from federal Income Tax under the provision of sections 501(c)(3) of the Internal Revenue Code or to the Federal, State or county government for exclusive public purpose. Any such assets not disposed of shall be disposed of by a court of competetent Jurisdiction of the county in which the principal offfice of the corporation is then located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

No Part of the earnings of this organization shall ever inure to the benefit of or be distributeable to its members, trustee, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distribution in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be carrying on of propangada, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
