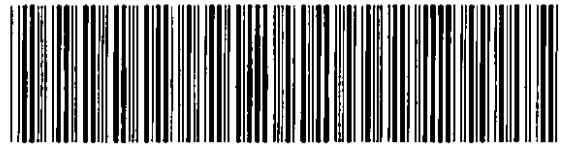

## ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S. (Not for Profit)

**ARTICLE I:** The name of the corporation shall be MARINE SCIENCE FOUNDATION, INC.

**ARTICLE II:** The principal street address and the mailing address is: 7560 SW Jack James Drive #C-19, Stuart, Fl 34997.

**ARTICLE III:** The purposes for which this nonprofit corporation is organized are:

(a) This nonprofit corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (the "Code"); and, in general, to exercise any, all and every power for which a non-profit corporation organized under the applicable provisions of the Florida Statutes, as amended, for educational, charitable, and/or religious purposes, and other non-profitable purposes, can be authorized to exercise, but only to the extent the exercise of such powers are in furtherance of an exempt purposes.

(b) No part of the net earnings of this nonprofit corporation shall inure to the benefit of, or be distributable to, its directors, trustees, officers, members or other private persons, except that the Corporation shall be empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles of Incorporation. No substantial part of the activities of the Corporation shall consist of promoting propaganda, or otherwise attempting to influence legislation, except as otherwise provided by the Code, and this nonprofit corporation shall not participate in, including the publishing or distribution of statements, any political campaign on behalf of, or in opposition to, any candidate for public office. Notwithstanding any other provision of these Articles of Incorporation, this nonprofit corporation shall not engage in any activities that are not permitted by a nonprofit corporation exempt from federal corporate income tax under Section 501(c)(3) of the Code.

(c) If at any time the Corporation is deemed to be a private foundation as defined in Section 509 of the Internal Revenue Code of 1986, as amended (or the corresponding section of any future federal tax code) (the "Code"), then so long as the Corporation is deemed a private foundation, it shall not, as provided in Section 508(c) of the Code, fail to require its income for each taxable year to be distributed at such time and in such manner as not to subject the Corporation to tax under Section 4942 of the Code, , or the corresponding section of any future federal tax code; engage in any act of self-dealing as defined in Section 4941(d) of the Code, retain any excess business holdings as defined in Section 4943(c) of the Code, or make any investments or expenditures in such manner as to subject the Corporation to tax under Section 4944 or Section 4945(d) of the Code.
