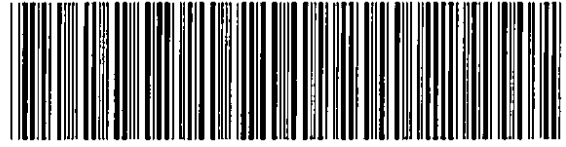

## KINGDOM OF ANGELS CHURCH: ARTICLES OF INCORPORATION

We, the undersigned, of full age, for the purpose of forming a religious, non-profit corporation under and pursuant to the provisions of Chapter 617 of the State of Florida Statutes Annotated, known as the State Nonprofit Corporation Act, and laws amendatory thereto, do hereby certify that at a regular meeting of the undersigned incorporators held on the 25th day of September 2023, in the State of Florida, pursuant to the provisions of Chapter 617, State Statutes Annotated, we did associate ourselves as a body corporate and did adopt the following Articles of Incorporation:

### ARTICLE 1: NAME

The Name of the Corporation shall be Kingdom of Angels Church, Corp., also named forward as “the Church” or “the Corporation”.

### ARTICLE 2: PURPOSE

The purpose of this corporation is to engage in charitable, educational, and religious activities as defined in section 501(c)(3) of the Internal Revenue Code, or its corresponding section in any future federal tax code.

### ARTICLE 3: STREET ADDRESS OFFICES / EMAIL

The Corporation shall maintain a principal office at 111 Briny Avenue suite 1914, Pompano Beach, FL 33062. Church Email Address is: [admin@kingdomofangels.org](mailto:admin@kingdomofangels.org). The location of the registered office of this corporation shall be State of Florida. The Church, following the parameters of globalization of these times, will also officiate its Sacred Rituals, Ceremonies, Sacraments, and its work of evangelism over the Internet. Also, with the approval and prior authorization of the Board of Directors, the homes, offices and places of residence of each of the Active Members of the Church may serve as satellite offices.

### ARTICLE 4: NON-PROFIT STATUS

This corporation is organized and operated exclusively for charitable, religious, educational, and scientific purposes under section 501(c)(3) of the Internal Revenue Code, or its corresponding section in any future federal tax code. No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to, its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 2.

### ARTICLE 5: vision

The corporation is organized exclusively for charitable, religious, cultural, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The Corporation is established to have an effective and direct relationship with the young people of our community who, from an early age, lead them in the plastic arts, music, literature, and other academic and cultural activities. It will also be the purpose of the Corporation to establish and maintain a Church modeled after the NeuroCosmica principles, and the Kingdom of Angels Book series, our Sacred Inspirational Books. The reason for the existence of our Congregation is Prosperity, Wellbeing, and Respect for our fellowmen without distinction of Gender, Race, Sex, Nationality, Degree of Academic Instruction, or any other reason that could generate differences or any type of discrimination. In this sense, the Prosperity of our Members becomes one of the Primordial Duties of the Vision and Objectives of the Kingdom of Angels Church. In that same spirit, the Tools used for the Evangelical Growth of Our Church we consider them as Sacramental Talents of Our Faith.

With that Vision, we carry the inspiration for people to take Control of their Existences, and basing the life of our parishioners on the non-perishable being, as the most direct way for them to be in permanent communication with their Cosmic Being. Yaleh, that inspires the Kingdom of Angels, our Sacred Book, is our main Prophet. Abaqua, His Divine Grace, is our Live Spiritual Leader. Abaqua is the hierarchical title that identifies our Spiritual Leader.

#### ARTICLE 6: Dissolution

"Dissolution" means the complete disbanding of the Corporation so that it no longer functions as a corporate entity. Upon the dissolution of the Corporation, its property shall be applied and distributed as follows: (1) all liabilities and obligations of the Corporation shall be paid and discharged or adequate provision shall be made therefore; (2) pursuant to a plan adopted by the board of directors, assets shall be transferred or conveyed to one or more domestic or foreign corporation, society, or organization that qualify according to the criteria of the Board of Directors, always guided by the wisdom of Abaqua, His Divine Grace.

#### ARTICLE 7: MEMBERSHIP

Any person who gives scriptural evidence of the saving faith in the Lord Yaleh, according to our non-discriminatory, environmentalist beliefs, of equal inclusion in sexual preferences, race, educational level, country of origin or residence, or their political inclinations, and completes and adheres to the standards of the Membership Course, shall be eligible to be Members in this Corporation. Our beliefs are in line with the philosophy of Life reflected in the NeuroCosmical principles', and the Kingdom of Angels, our Sacred Books, written and unraveled by Abaqua, His Divine Grace, and our Living Prophet. All Active Members of the Church have the possibility to ascend in the Hierarchy of the Congregation, and even be named by Abaqua as part of the trilogy where the new Abaqua will be chosen, when He transforms his Divine body to meet with His peers in the Cosmic Kingdom of Angels.

#### ARTICLE 8: Prerogatives AND OVERSIGHT Governance

The Kingdom of Angels Church shall be spiritually directed for life by Abaqua, His Divine Grace, our living Prophet, who also can be or not the President of the Knights Council Leadership Team and the highest governance of the Church. The Knights Council Leadership Team of the Kingdom of Angels Church shall act as the governing authority by providing spiritual guidance, setting its major policies, and exercising responsibility for its business and activities. Officers: The officers of this corporation shall be the President and Members of the Knights Council Leadership Team unless otherwise provided by the bylaws of this Corporation. The terms of officers shall be a period as designated by the bylaws.

#### ARTICLE 9: Affiliation

While maintaining its inherent rights to sovereignty in the conduct of its own affairs as herein set forth, the Kingdom of Angels Church voluntarily commits to enter into fellowship and partnership with like-minded and charged organizations as it sees fit or is necessary to accomplish its mission.

#### ARTICLE 10: Autonomy

The Kingdom of Angels Church is autonomous and maintains the right to govern itself and to conduct its own affairs, including without limitation, the calling of a Lead Prophet, the selection of the Knights Council Leadership Team (Board of Directors), and the implementation of its own ministries. Kingdom of Angels Church shall also have the right to purchase or acquire by gift, bequest or otherwise, either directly or as trustee, and to own, hold in trust, use, sell, convey, lease, or otherwise dispose of any real estate or property as may be necessary for the furtherance of its purposes, and to exercise all other powers conferred upon it by its State, or other applicable Laws of the State.

#### ARTICLE 11: TENETS OF FAITH

The book series, Kingdom of Angels, written by Omegh Ocho, serves as our Sacred Inspirational Books. Other NeuroCosmical Books written by Omegh Ocho are also considered instruments of Spiritual Guidance for our Church. The Kingdom of Angels book series shall be the rule and guide of Faith, as set forth in the Statement of Beliefs. Additionally, the teachings and knowledge contained in the books "NeuroCosmica: SIFA," "NeuroCosmica: The Order," "NeuroCosmica: The Golden Book," "Yaleh," and "NeuroCosmica: A Way of Life" are considered Sacred Books whose precepts should be observed by the Members of the Church. The book series "Kingdom of Angels," written by Omegh Ocho, reflects the history of the members of the Kingdom of Angels from millions of years ago (See Exhibit "A").

#### ARTICLE 12: BOARD OF DIRECTORS (Knights Council Leadership Team)

Armando De José Mantilla, Secretary of the Corporation holds the title of first Abaqua, His Divine Grace, our living Prophet. The incorporators, who constitute the first Board of Directors—Leadership Team of the Council of Knights—, elected in accordance with the statutes—of this Corporation, are:

#### ARTICLE 13: AMENDMENTS

Amendments to these Articles of Incorporation will be guided by Abaqua, His Divine Grace, in cooperation with the Board of Directors (Knights Council Leadership Team), at any regular or special business meeting. After the consideration and completion of recommended changes, an amendment will be presented to the Council of Overseers for revision, if this body has already been constituted.

Otherwise, the decision of the Board of Directors will validate it.

#### EXHIBIT A: STATEMENT OF BELIEFS

The Kingdom of Angels Church recognizes that it cannot, and does not desire to, bind the conscience of individuals in areas where the Kingdom of Angels book series, our Sacred Scriptures, are silent. Rather, each believer is to be led in those areas by Yahveh, as assured in the Kingdom of Angels book series — our Sacred Books — to whom he or she alone is ultimately responsible. We believe the Statement of Beliefs to be an accurate summary of what our Sacred Inspirational Books and other NeuroCosmical Scriptures teach.

The Kingdom of Angels' book series, our Sacred Books, conveys the Revelation of Yahveh to humanity. We consider it the Authority of Faith and Conduct, and a group of councilors of the Kingdom is responsible for it. NeuroCosmica is the underlying structure of principles that explain the existence of life as we know it in this dimension. The growth of Epic and Essence Vital Intelligence in this world depends on the binding of native-component material.

Our Prophet, Abaqua, initiated NeuroCosmica to provide a logical explanation for the origin and role of humans in the Universe. Abaqua identified two key parts of the Being and delved beyond human knowledge to understand the non-physical one. He reminds us that we need to reconsider our narrative to comprehend our unique nature and prevent the extinction of life.

Abaqua, His Divine Grace, founded the NeuroCosmica Institute to study our holy texts and beliefs.

Abaqua delegated and instructed Omegh Eight with all the fundamental principles of NeuroCosmica.

This is how Omegh wrote the books that founded NeuroCosmica and also the Kingdom of Angels book series.

#### RITUALS OR SACRAMENTS CEREMONIES OF PURIFICATION

Our Church assumes within its Beliefs 18 main Rituals of Purification. Ceremonies where NeuroCosmical aspects come together, with flows of energy inherent in the human condition of some of the bidders. A Ritual must be led by a Facilitator / Practitioner, duly certified by the NeuroCosmica Institute, who may or may not be present at his execution. These are the 18 main Sacramental Rituals of our Faith:

13. Ritual of Against Intruders
14. Ritual of the Touch
15. Ritual of Consciousness of Existence
16. Ritual of Life Transfer
17. Ritual of Body Transformation
18. Ritual of the Immortality

**IMPORTANT:** No one with the title of Prince of the Church or any other title can call themselves a healing physician or shaman, or possess special powers. We regard each ritual as a pillar and a Sacred Sacrament of our Faith.

#### Light Medicine

In the Kingdom of Angels Church, we firmly believe that diseases begin with alterations or imbalances between the Vital Essence of the Being (Cosmic Body) and the earthly vehicle that contains it (the physical body). For this reason, our Church applies corrective Positive Light to address these imbalances, with the confidence that it adapts and empowers the human body to repel the most common known diseases. As with the Rituals, Light Medicine can only be administered by a Facilitator/Practitioner who is duly certified by the NeuroCosmica Institute. In some exceptional cases, it may be administered by Knights who are duly authorized by Abaqua, His Divine Grace. All these practices are considered Sacraments of our Faith. Those who receive these sacramental practices are obligated to continue following the prescriptions issued by a doctor who is duly authorized and holds a valid license from the Board of Medicine to practice in the locality where the recipient of the sacraments resides. Teraphim and amulets are objects, physical or luminous, associated with Light Medicine and, therefore, their use is also considered dogmas of our Faith.

#### Knights Council Leadership Team AND PRINCES OF THE CHURCH

The Titles of the Knights-Princes of our Church according to their Spiritual Hierarchy are:

1. Knights of Wisdom
2. Baronets of Knowledge
3. Barons of the Radiant Light
4. Viscounts of the Oracle
5. Earls of the Origin
6. Marquesses of the Golden Camera
7. Dukes of the Stars
8. Archdukes of Terra
9. Princes of the Kingdom

Note: All Titles are granted by the Lords of the Kingdom of Angels Church are in the male gender shall be deemed to include the female or neuter gender. Any member of the Church can access the different Titles mentioned here, because they represent the work of Evangelism of each Member. Any Active Member of the Church may adopt the Name of Abaqua, followed by a number, provided it is duly authorized by Abaqua Eight, His Divine Grace. Any Title granted may be withdrawn by the Church if its holder does not comply with the guidelines of conduct of the Church. All Officers, Knights, and the

Knights Council Leadership Team are under the Spiritual and Organizational Authority of Abaqua, His Divine Grace, our Living Prophet.

#### BYLAWS

These Bylaws govern the affairs of the Kingdom of Angels Church, Corp., a Non for Profit Corporation pursuant to the provisions of Chapter 617 of the Florida State Statutes Annotated, known as the State of Florida Nonprofit Corporation Act.

#### PREAMBLE

These Bylaws are intended to provide a simple but adequate form to govern the Church in the State of Florida, in the United States or anywhere in the world where a branch is established. Such establishment must be duly authorized by the authorities of the original Corporation. The Bylaws aim to advance strong covenantal relationships and to ensure that any issues that do arise will be quickly addressed and remedied through their application.

Accordingly, the Kingdom of Angels Church, a State of Florida, nonprofit Corporation, by the solemn and unanimous action of its Board of Directors, hereby adopts these Bylaws. The Board of Directors —the Knights Council Leadership Team— and members willingly submit to be governed by them so that the Kingdom of Angels Church may effectively carry out the Vision of the Church. Furthermore, these Bylaws shall constitute and evidence the agreement by and among the Board of Directors —the Knights Council Leadership Team—, that its governance, business, and activities shall be conducted as provided in these Bylaws.

#### ARTICLE 1: the Knights Council Leadership Team (BOARD OF DIRECTORS)

1.01. Function: The Knights Council Leadership Team (also known as the “Board of Directors”) shall provide spiritual guidance and shall manage the affairs of the Corporation.

1.02. Qualifications: Our Philosophy within NeuroCosmica provides Professional Training, and Properly Educated Practitioners who, in due course, will constitute the seedbed from which will be chosen the Members of the Knights Council Leadership Team. Therefore, the Governing Council of the Kingdom of Angels Church consists of a Knights Council Leadership Team. In addition to the prerequisites of being a Knights outlined in 1.02 and the expectations of the Knights Council Leadership Team outlined in 1.03. Provisional members of the Knights Council Leadership Team, if necessary, may be appointed by shall by Abaqua, His Divine Grace, our living Prophet.

1.03 Duties: The duty of the Knights Council Leadership Team is to govern the flock, and all the parishioners which shall include the following:

- (a) Direct all the affairs of the church to ensure that the mission is accomplished in a spirit of unity, including business decisions enacted upon the advice of the Council of Overseers.
- (b) Oversee the provision of the physical facilities needed by the Kingdom of Angels Church, including the buying and selling of real estate and securing real estate leases.
- (c) Be responsible for any construction project (the actual coordination of a construction project may be delegated to a Building Team).
- (d) Work in cooperation with the Council of Overseers as a Knights Search Team to assist in locating a new Lead Knights (e) Appoint other Knights.

1.04. Number and Term of Board of Directors: The powers of the Corporation shall be exercised by or under the authority of the Knights Council Leadership Team (Board of Directors), and the property, business, and affairs of the Corporation shall be managed under the direction of the Knights Council Leadership Team. The total number of Board of Directors shall not be less than three (3). Each director shall serve for a period of two (2) years, but can serve successive terms. The Directors have to be active Members of the Corporation. Directors shall be natural persons. Abaqua position is lifelong. Only Abaqua, His Divine Grace, has the power to restructure the Board of Directors when circumstances warrant it according to his divine judgment and decision, including the power to increase the number of Members, but never reduce it to less than three Members.

1.05. Appointment of Directors: The Knights Council Leadership Team will designate the persons they consider qualified to serve as Directors, chosen always from among the Knights of the Church, and always following the wisdom and point of view of Abaqua, His Divine Grace.

1.06. Vacancies: Only Abaqua, His Divine Grace, shall fill a vacancy occurring on the Knights Council Leadership Team, chosen from the candidates presented by the Council. Vacancies reducing the number of Directors to less than three (3) shall be filled before the transaction of any other business. The Corporation's Knights Council Leadership Team shall be comprised solely of Staff Knights. However, if it becomes necessary for a non-Staff Knight to be appointed to fill a vacancy, which shall only occur if it is necessary to raise the number of directors to at least three, said replacement shall only serve as long as necessary before a suitable Staff Knight replacement can be located.

1.07. Limits of Authority: the Knights Council Leadership Team is responsible for all decisions for the Kingdom of Angels Church. Abaqua, His Divine Grace, shall preside over all decisions as long as the issue at hand does not involve a conflict of interest for the Abaqua, and that is not possible since Abaqua, His Divine Grace, according to our faith and beliefs, is infallible in his decisions and judgments.

1.08. Meetings: Abaqua, His Divine Grace, shall preside over all meetings of the Knights Council Leadership Team. If it is not possible for Abaqua to attend, then His Divine Grace shall designate a chairman for the meeting. All decisions require a simple majority of those present. Any motions passed and recorded in a meeting without Abaqua may not take effect without the consent of His Divine Grace — Abaqua — or until the following meeting if Abaqua is present and the minutes of the previous meeting are approved. The Knights Council Leadership Team will meet once a year and may convene more often at the discretion of Abaqua, His Divine Grace. Notification must be made at least ten (10) days in advance of the meeting.

1.09. Action by Consent of Board of Directors without Meeting: Any action required or permitted to be taken by the Knights Council Leadership Team may be taken without a meeting, and with the same force and effect as a unanimous vote of Directors, if all members of the Board consent in writing to the action. Such consent may be given individually or collectively.

1.10. Quorum: A majority of the number of Directors then in office shall constitute a quorum for the transaction of business at any meeting of the Knights Council Leadership Team. The Directors present at a duly called or held meeting at which a quorum is present may continue to transact business, even if enough Directors leave the meeting so that less than a quorum remains. However, no action may be approved without the vote of at least a majority of the number of Directors required to constitute a quorum. If a quorum is not present at any time during a meeting, a majority of the Directors present may adjourn and reconvene the meeting one time without further notice.

1.11. Proxies: Voting by proxy is prohibited.

1.12. Compensation: Directors shall receive salaries or compensation for their services as Board members. In addition, the Church may designate funds, as considered necessary given their high investiture, for activities related to Evangelism, travel, transportation, lodging, food, and other activities developed by any Member of the Board. If one of the Members of the Knights Council Leadership Team performs administrative or professional tasks of any other type within the Church, they can receive remuneration according to these specific tasks. In that case, the payment shall be fixed by consensus expressed by a simple majority of the Members of the Board of Directors, without the participation of the interested party. Abaqua, His Divine Grace, does not receive any kind of monetary compensation for being the Spiritual Guide of the Kingdom of Angels Church, nor for any of the other functions within the Congregation.

1.13. Removal of Directors: The Knights Council Leadership Team may vote to remove a Director, other than Abaqua, at any time, for the proper functioning of the Church, without good cause.

1.14. Removal of the President: The Knights Council Leadership Team may vote to remove a President, as long as that president is not Abaqua, at any time, for the proper functioning of the Church, without

good cause. Additionally, the Board of ex-presidents has the power to restructure the Board of Directors, remove, or replace the President of the Corporation if it is required or if there is a shortfall in the administration of the Corporation.

1.15. Removal of Abaqua: Abaqua, His Divine Grace, cannot be removed. That is not possible, as according to our faith and beliefs, Abaqua is infallible in his decisions and judgments. Abaqua position is lifelong. However, Abaqua, His Divine Grace, could choose to abdicate in favor of a hereditary Abaqua selected from a list of candidates previously presented by His Divine Grace for the purpose of selecting his successor.

1.16 Participation of Spouses: Spouses of the Knights Council Leadership Team Members are encouraged to participate in all relevant meetings, activities, and functions unless otherwise requested by Abaqua due to the nature of the meeting, activity, or function. However, spouses will have a voice but will not vote in meetings where they participate alongside their partners, and where their spouses make decisions inherent to the nature of their positions within the Church. The time and manner of participation of the spouses are determined in advance by the Knights Council Leadership Team or by Abaqua, His Divine Grace, if He presides over the aforementioned meeting.

#### ARTICLE 2: COUNCIL OF OVERSEERS

2.01. Function: The Council of Overseers is comprised of the Knights of the Church, whether or not they are Members of the Board of Directors. They serve to support, encourage, and provide accountability for the fulfillment of the church's vision. They shall vote on the ratification of the following decisions:

- (a) Advise Abaqua when His Divine Grace so requests.
- (b) The purchase or sale of any asset(s), real or personal, during a calendar year in an amount that exceeds the lower of either 20% of the approved operating budget for the year or \$500,000.00.
- (c) Amendments to these Bylaws, with previous approval or at the request of Abaqua.
- (d) Altering terms of employment of employees during an interim period between any Directors, except Abaqua, His Divine Grace.
- (e) Disaffiliation/Affiliation with an Affiliate Network, with previous approval, or at the request of Abaqua, His Divine Grace.
- (f) Termination or discipline of any Director or any other Member of the Knights Council Leadership Team, except Abaqua, His Divine Grace.
- (g) Approval of the annual budget, with previous approval or at the request of Abaqua, His Divine Grace.
- (h) Compensation review, advising Abaqua, His Divine Grace, on staff compensations and setting the compensation of the Directors and the compensation of the Knights Council Leadership Team.

2.02. Eligibility: The Members of the Council of Overseers must be active Lead or Senior NeuroCosmica Facilitators or Practitioners, Knights of respected Congregations who know and love the Kingdom of Angels Church and Abaqua, His Divine Grace. They must agree to make themselves available at their own expense to serve the Kingdom of Angels Church if requested by the Knights Council Leadership Team or by Abaqua, His Divine Grace. Additionally, they must be willing to provide spiritual protection to the church through prayer and by living an honorable NeuroCosmical Christian lifestyle, in accordance with the non-discriminatory Philosophy recorded in the NeuroCosmica teachings of Abaqua.

2.03. Oversight by Council of Overseers: Upon informing Abaqua — and with the previous approval of His Divine Grace — the Kingdom of Angels Church may seek advice and assistance from the Council of Overseers in dealing with or mediating issues within the church, upon the request of any of the following: (a) Abaqua; (b) At least two of the Knights Council Leadership Team; or (c) A unanimous request of the Board of Directors by signed petition.

2.04. Appointment and/or Removal: The Knights Council Leadership Team and/or Abaqua, His Divine Grace, shall name the persons to serve as the Council of Overseers. The Members of the Board of Directors shall affirm the appointments. This same body also has the sole authority to remove Overseers designated with apostolic oversight for the Kingdom of Angels Church. Not more than three Overseers



may be removed per year, except when Abaqua considers it necessary for the proper functioning of the whole Congregation. In the event an Overseer resigns or is removed, a replacement will be immediately sought by Abaqua and affirmed at the next Knights Council Leadership Team meeting. If disciplinary action is being considered, changes in the Board of Overseers may not be made until its work is completed.

2.05. Compensation: The Council of Overseers shall not receive any compensation for their services on the Council but may be reimbursed for substantiated out-of-pocket expenses incurred while serving the Church in their advisory capacity. Additionally, the Church may designate funds for activities related to evangelism, travel, transportation, lodging, food, and/or other activities developed by any Member of the Council.

2.06. Number: The number of Overseers shall not be fewer than five. However, if there are not enough Members to reach that Category, the functions of the Overseers are assumed by the Board of Directors (the Knights Council Leadership Team), and they must be elected from among the Princes of the Church.

2.07. Meetings: Abaqua, His Divine Grace, shall preside over all meetings of the Council of Overseers. In the event that Abaqua is unable to attend, His Divine Grace shall appoint an acting chairperson for the meeting. All decisions shall be made by a simple majority vote of those present. The Overseers will convene annually and may hold additional meetings at Abaqua discretion. These meetings may take place in person or through teleconference or web conference.

#### ARTICLE 3: PARTNERS

3.01. Partners: The words 'Partner,' as used in these Bylaws, solely denote individuals who participate in the spiritual activities and ministries of Kingdom of Angels Church. The term 'Partnership,' mentioned herein, signifies only a spiritual unity and shall not be construed to hold any legal status under Florida State Law.

#### ARTICLE 4: MEMBERS

4.01. Members: Members shall include all individuals who officially covenant together and agree, in writing, to fulfill the vision of the Kingdom of Angels Church. The term 'Member' shall not be interpreted as conferring any ownership in the Kingdom of Angels Church. Similarly, the term 'Membership,' as referenced herein, signifies only a spiritual unity and shall not be construed as having any legal status under State Law, except as provided in Section 10.4.

4.02. Eligibility: Individuals at Kingdom of Angels Church may become Members in good standing (actives) if they satisfy the following criteria:

- (a) Being born again in the principles of a NeuroCosmical Life, demonstrating a consistent NeuroCosmical life in alignment with the Non-Discriminatory Principles of our Sacred Books — Kingdom of Angels Series — and other NeuroCosmical Scriptures written by Abaqua, His Divine Grace.
- (b) Completing and adhering to the standards of the Leadership/Membership Courses (NeuroCosmica Institute), as administered by the leadership of the Church at various opportunities throughout the calendar year.
- (c) Fully subscribing to the Statement of Beliefs as set forth in the Articles of Incorporation, Exhibit A.
- (d) Being at least eighteen (18) years of age.
- (e) Regularly attending the weekly worship services, either in person or online.
- (f) Contributing to the financial support of the Kingdom of Angels Church in the form of a tithe, only if there is a surplus in the financial statement, as determined by the financial organization established by the Kingdom of Angels Church for its evangelizing development.

4.03. Appointment and Removal: Individuals who possess the above qualifications and desire to officially participate in the Vision and Mission of the Kingdom of Angels Church as a Member shall attend all required classes and meetings as determined by the Knights Council Leadership Team. Afterward, they shall present their names to the Knights Council Leadership Team for approval. Their names will be added to the Membership roster once they have met the Membership requirements. Those approved

for Membership by the Knights Council Leadership Team shall be encouraged to attend a primary service to be received into the Church publicly.

The Knights Council Leadership Team — or Abaqua, His Divine Grace — shall have the right to remove any Member that fits into the following criteria:

- a) A Member's conduct and lifestyle violate the standards of the Kingdom of Angels Book Philosophy, and the individual refuses correction.
- b) A Member leaves the Church due to apostasy from the Principles of the Church.
- c) A member refuses NeuroCosmical principles, as set out in Abaqua's teachings about it.
- d) A member requests to be removed.
- e) Six months pass without any record of contribution or attendance. In this case, the Member is indicating to the Kingdom of Angels Church that they are resigning their membership due to inactivity.
- f) A Member is not in harmony with the Vision or leadership of the Kingdom of Angels Church.
- g) A Member who does not accept Abaqua Divine condition, or who does not agree that Abaqua, His Divine Grace, is the rightful representative on the earth of our Lord Yaleh.

4.04. Advice and Confirmation: Members shall provide advice and, as the case may be, give or withhold confirmation concerning proposals made by the Knights Council Leadership Team for matters affecting the spiritual health and mission of the Kingdom of Angels Church. Regarding all major decisions of the Kingdom of Angels Church, the Knights Council Leadership Team may seek non-binding advice from the Members in whatever format they deem necessary at the time. However, the decision of the Knights Council Leadership Team on matters other than those set forth in this section shall be final and at its sole discretion.

4.05. Member Meetings: Abaqua, His Divine Grace, shall preside over and solely call all Member meetings.

(a) The Annual State of the Church Meeting shall be held in the first quarter of every year at a time and place determined by the Knights Council Leadership Team. The purpose of this meeting is to present information pertaining to the business of the church, as well as matters related to evangelism and teachings of our Faith. Notice of this meeting shall be given for at least two (2) successive Tuesdays immediately preceding it, through church publications and announcements.

(b) Special Membership meetings can be called by the Senior Priests Knights Council (former Members of the Knights Council Leadership Team) in cooperation with the Knights Council Leadership Team. Notice for these meetings shall be given for two successive Sundays immediately preceding the meeting through church publications and announcements. The notice shall state the purpose of the meeting.

(c) Membership meetings of the Church shall follow acceptable procedures that align with the spirit of NeuroCosmical Christian love and fellowship.

(d) It is understood that all active Members should have the opportunity to voice concerns or seek additional information from Abaqua, His Divine Grace, or the Knights Council Leadership Team prior to official meetings.

4.06. Voting and Quorum: A quorum shall consist of all Members in good standing who are present. No vote shall be taken at any Member meeting except as authorized by the Knights Council Leadership Team or Abaqua, His Divine Grace. To be eligible to vote, a Member must be present to participate in discussions prior to a vote.

4.07. Establishing Initial Membership: For the purpose of adopting these bylaws, provisional Membership shall be granted to the Knights Council Leadership Team Staff and the individuals who made up the original Kingdom of Angels Church Launch Team. Their Membership status will be confirmed upon completion of the NeuroCosmica Membership course when offered by the Knights Council Leadership Team.

ARTICLE 5: Knights Lieutenant

5.01. Function: Knights Lieutenants are a specialized group of Members who are appointed by the Knights Council Leadership Team to assist in the spiritual ministry of the Kingdom of Angels Church. They are to be considered Servant Leaders and are selected to serve as Priests and Knight's Helpers due to their already proven value and ministry in the church. They form the spiritual backbone of the Kingdom of Angels Church.

5.02. Prerequisites for Knights Lieutenant: Being a Member in good standing is a prerequisite for serving as a Knights Lieutenant. Furthermore, in order to be eligible to serve in said roles, a Member must possess the following qualities:

- (a) Demonstrate the calling, character, competence, chemistry, and culture of leadership conducive to the Kingdom of Angels Church environment.
- (b) Support the other Knights and refrain from divisive attitudes and behavior.
- (c) Have wisdom, a good reputation, exemplary conduct, and self-control.
- (d) Be committed to a covenant relationship with his/her spouse if married.
- (e) Manage their own household wisely – being attentive to his/her own children, having their respect, and keeping them under control with true dignity.
- (f) Not given to excessive drinking of alcoholic beverages and abstain from all illegal drugs.
- (g) Abstain from all forms of extra-marital sensual behavior.
- (h) Not be a new convert (less than six months in the Church).
- (i) Be a full Active Member for at least six months.
- (j) Hold firmly to sound Scriptural doctrine so that he will be able to exhort and encourage others to good works and disprove those who speak against the NeuroCosmica and the Tenets of Faith of Kingdom of Angels Church, and its process of evangelism and growth.
- (k) Contribute in tithes and offerings to the mission of NeuroCosmica and the Kingdom of Angels Church.

5.03. Duties: The duties of the Knights Lieutenants include the following:

- (a) Prayer and intercession for Abaqua, the Knights Council Leadership Team, and the Sacred Kingdom of Angels Church.
- (b) Special Ministry projects as directed by the Knights Council Leadership Team.
- (c) Prayer and counseling of the church Partners and Members.
- (d) The Knights Lieutenants can call on the Council of Overseers to review a moral or ethical problem involving the Knights Council Leadership Team (except Abaqua, His Divine Grace) that is documented by more than three witnesses. A signed request for intervention by all Knights Lieutenants must be sent to the Council of Overseers and a copy sent to Abaqua, His Divine Grace.

5.04. Appointment and Removal of Knights Lieutenant: The Knights Council Leadership Team appoints the individual / couple to be a Knights Lieutenant. There are no term limits; their appointment lasts as long as they or Abaqua, His Divine Grace, so desires. Abaqua, His Divine Grace, or the Knights Council Leadership Team may remove any Knights Lieutenant at its sole discretion at any time unless otherwise specified herein.

5.05. Meetings: Abaqua, His Divine Grace, or one or more of the Princesses of His Court of Assistants, shall call and preside over all Knights Lieutenant Meetings. The Knights Lieutenants will meet at least once per year to hear the heart of Abaqua, His Divine Grace. They may meet more often at the discretion of His Divine Grace.

#### ARTICLE 6: ABAQUA, HIS DIVINE GRACE

6.01. Function: Abaqua, His Divine Grace, is the Spiritual Lifelong Guide of the Kingdom of Angels Church, shall serve as the Spiritual Overseer of Kingdom of Angels Church, and may or may not be the President of the Corporation and the Chairman of the Board of Directors (Knights Council Leadership Team).

6.02. Duties: The Duties of Abaqua, His Divine Grace, include the following:

(a) **Spiritual Oversight:** Abaqua, His Divine Grace, shall work cooperatively with the Council of Overseers, the Knights Council Leadership Team, Knights Lieutenants, Members, and Partners. Abaqua shall establish and communicate the God-given vision and mission of the Church, oversee and coordinate the day-to-day ministry, and manage the day-to-day administration of the Church. He is also responsible for selecting the Members of the Council of Overseers.

(b) **Corporate Oversight:** Abaqua, His Divine Grace, shall also serve as the Chief Executive Officer of the Corporation, Chairman of the Knights Council Leadership Team, and Chairman of Member Meetings, according to the Articles of Incorporation. He shall oversee all ongoing activities related to the development, implementation, and maintenance of the spiritual and temporal mission and business of the Church. He shall follow and adhere to the policies and procedures, both assumed and specifically outlined in these Bylaws, in compliance with federal, state, and municipal laws.

(c) **Meetings:** Abaqua, His Divine Grace, shall preside over all meetings of the Knights Council Leadership Team and serve as the Board of Directors for the Corporation, ensuring that all orders and resolutions of that team are fulfilled. Abaqua, His Divine Grace, shall also call the meetings for the Knights Council Leadership Team and determine the agenda for each meeting. He shall execute, in the name of the Kingdom of Angels Church, all deeds, contracts, loans, and other documents under the advice of the Treasurer and confirmation from the Knights Council Leadership Team. He shall also serve as an official member of the Knights Lieutenants, as well as all Ministry Teams, connection groups, or any other group that meets within the body of the Kingdom of Angels Church, and shall have the general powers and duties of supervision and management usually vested in the executive office of any corporation.

(d) **Budget and Expenditures:** Since Abaqua, His Divine Grace, is primarily responsible for the spiritual life of Kingdom of Angels Church, he shall also have corporate authority to make expenditures within the approved budget by the Knights Council Leadership Team. Abaqua, under the advice of the Council of Overseers, ensures that the financial strength of the Church is directed according to the directives of the ministry of the Knights Council Leadership Team. Abaqua, His Divine Grace, with the assistance of the Treasurer, shall be responsible for the preparation of an annual budget and its submission to the Knights Council Leadership Team upon the approval of the Council of Overseers.

(e) **Compensation:** The Council of Overseers (or the Knights Council Leadership Team, if the Council of Overseers is not yet properly constituted) will serve as the Compensation Team for the review of salary packages for all staff of the Church. These packages are determined by Abaqua, His Divine Grace, or His designees. This also includes covering all the expenses incurred by His Divine Grace, such as trips, mobilization, clothing, etc. It's important to note that Abaqua, His Divine Grace, does not receive any form of monetary compensation for his role as the Spiritual Guide of the Church of the Kingdom of Angels or for any other functions within the Congregation.

6.03. **Qualifications:** Abaqua, His Divine Grace, is the Founder of NeuroCosmica, the Author of the Kingdom of Angels Book series (our Sacred Books), and inspired by Yahel, our Lord, initiated the Kingdom of Angels Church. Abaqua is also the legitimate Representative of the Kingdom of Angels on planet Earth and, as such, is a part of the Universal Cosmic Council of the Kingdom of Angels. According to the beliefs and dogmas of Faith of the Church of the Kingdom of Angels, Abaqua is considered infallible in His judgments and appreciations within the Articles and Rules that govern the Kingdom of Angels Church.

6.04. **Appointment and/or Removal:** According to our Faith and beliefs that we accept, Abaqua, His Divine Grace, has been chosen by Our Lord Yahel to lead His Church on earth. He leads under His wise inspiration the process of evangelism of the NeuroCosmical philosophy and chooses His successor when He decides to meet His Divine Grace with His Alos pairs in the Cosmic Kingdom of Angels, our Heaven. Therefore, no mortal has the power to elect or remove Abaqua, His Divine Grace, or those who, at their sole discretion, succeed Him in the highest hierarchy of our Church. However, in the event that Abaqua, His Divine Grace, becomes the President of the Corporation and is unable to perform that corporate

function, he may be replaced by one of the Members of the Board of Directors until his replacement is duly elected. Provisions for this purpose are contemplated in 6.05.

6.05. Transition between Abaqua, His Divine Grace and the Abaqua Successor that He, in His Divine Wisdom designates: To ensure the unity of the Church by a smooth transition between our highest hierarchies, the following procedures will be followed:

(a) Governance during the Interim: At Abaqua discretion, as provided for by His Divine Grace in the full exercise of his faculties and infallibility, the Knights Council Leadership Team, in conjunction with the Council of Overseers, shall select a Prince of the Church from a trio of candidates envisioned by Abaqua, His Divine Grace, to fulfill the basic obligations until the new Abaqua is anointed.

(b) Function and Limits of an Interim Prince of the Church until the new Abaqua is anointed: The Interim Prince of the Church shall not alter the philosophy of the Kingdom of Angels Church to reflect his own personal views. The Interim Prince of the Church shall cover the primary preaching schedule, fulfill the basic care duties of Abaqua, and ensure that the ministries of the Kingdom of Angels Church continue to function. The Interim Prince of the Church shall not possess any other corporate powers granted to Abaqua by these Bylaws. In the event that an Interim Prince of the Church is secured from outside the Kingdom of Angels Church, he shall be compensated for his service at a fair salary mutually agreed upon by the Interim Prince of the Church, the Knights Council Leadership Team, the Treasurer, and the Council of Overseers.

(c) Administration during the Interim Period: During the interim period between the anointment of the new Abaqua, members of the Knights Council Leadership Team are to continue in their positions. Should leadership or financial problems arise, the Interim Knight shall have the authority to alter the duties, roles, and/or terms of employment of all employees and the terms of service for all volunteer leadership positions, including dismissal if necessary, upon the ratification of the Council of Overseers. Any employees serving under a previous Abaqua, His Divine Grace, shall tender their resignations to the new Abaqua immediately upon the anointment of the new Abaqua. The new Abaqua shall have up to three months to accept or reject said resignations. When the new Abaqua, His Divine Grace, is in place, He has full authority to select His staff, replacing existing staff members if He should so choose, but always giving priority to the provisions laid down by the Founder of the Church, Abaqua, for the coming generations.

#### ARTICLE 7: KNIGHTS STAFF

7.01. Function: A Staff Knights Council Leadership Team includes a staff member who is assigned ministerial and evangelism responsibilities by the Senior Council, under the discretion of Abaqua, His Divine Grace.

7.02. Qualifications: A Staff Knights Council Leadership Team must meet the qualifications of a Knight as described in 5.02 and must be a credentialed Knight in good standing. Any additional qualifications will be determined by Abaqua, His Divine Grace.

7.03. Responsibilities: The responsibilities and duties shall be assigned by Abaqua, His Divine Grace.

7.04. Appointment/Dismissal: A Staff Knights Council Leadership Team shall be appointed or dismissed by Abaqua, His Divine Grace, with consideration from the Knights Council Leadership Team and/or the Council of Overseers.

#### ARTICLE 8: OFFICERS

8.01. Officer Positions: The officers of the Corporation shall consist of a President, a Secretary/Treasurer, a Vice President, and Directors. The Knights Council Leadership Team may create additional officer positions, define the authority and duties of each such position, and elect or appoint members to fill the positions. Any two or more offices may be held by the same person, except for the offices of President and Secretary.

8.02. Election and Term of Office: The new officers of the Corporation shall be appointed by Abaqua, His Divine Grace, and confirmed by the Knights Council Leadership Team. Each officer shall hold office until a successor is duly elected and appointed.

8.03. Removal: Any officer, other than the President, may be removed by Abaqua, His Divine Grace, in His sole discretion, or with the confirmation of the Council of Overseers.

8.04. Removal of the President: If the President is Abaqua, His Divine Grace, he cannot be removed. According to our faith and beliefs, Abaqua is considered infallible in his decisions and judgments, and his position is lifelong. However, in the event that Abaqua, His Divine Grace, becomes the President of the Corporation but is unable to perform that corporate function, he may be replaced by one of the Members of the Board of Directors until his replacement is duly elected. Provisions for this purpose are contemplated in Section 6.05. Additionally, the Board of Ex-Presidents of the Corporation may designate an interim President until the new President is appointed or elected. The Board of Ex-Presidents may also determine the period of time necessary for the interim President to exercise his functions; in which case, the new President shall be appointed or elected once the time of execution decided by the Board of Former Presidents for the interim President has concluded.

8.05. Resignation: Any officer may resign at any time by giving written notice to the Board of Directors, the President, or the Secretary. Such resignation shall take effect at the time specified in the notice. The acceptance of such resignation shall not be necessary to make it effective.

8.06. President: The President shall be the Chief Executive Officer of the Corporation. The President shall supervise and control all of the business and affairs of the Corporation and may execute any deeds, mortgages, bonds, contracts, or other instruments that the Knights Council Leadership Team authorizes to be executed, or in His sole discretion. The President shall provide spiritual leadership to the Corporation. The President shall perform other duties prescribed by the Knights Council Leadership Team and all duties incident to the office of President.

8.07. Vice-President: When the President is absent, is unable to act, or refuses to act, the Vice President shall perform His duties, except during the transition between Abaqua, upon the new Abaqua is anointed. When the Vice President acts in place of the President, he or she shall have all the powers of and be subject to all the restrictions upon the President. The Vice President shall perform other duties as assigned by the President and be present at all Council of Overseer Meetings.

8.08. Secretary/Treasurer: The Secretary/Treasurer should be an officer of the corporation on the Knights Council Leadership Team. As Secretary, the Secretary/Treasurer shall act as clerk and record (or have recorded) all votes and the minutes of all proceedings in a book kept for that purpose. They shall oversee the maintenance of the corporation's membership rolls and perform the duties typically associated with the office of secretary. Additionally, they shall oversee any further duties prescribed by the Knights Council Leadership Team or by Abaqua, His Divine Grace, and/or the President from time to time. The position of Treasurer does not come with any form of remuneration. However, Abaqua, His Divine Grace, can assign them the necessary and appropriate evangelism aids to enable the Secretary/Treasurer to carry out their work effectively.

8.09. Treasurer's role over Accounting: As Treasurer, the Secretary/Treasurer shall be responsible for maintaining accurate records of all receipts and disbursements in books owned by the Corporation. They shall oversee the deposit of all funds and valuable assets in the Corporation's name and under the direction of Abaqua, His Divine Grace, and the President, into banks and depositories as designated. The Secretary/Treasurer will collaborate with the President in the creation of the annual budget by providing necessary financial information, although they do not have the authority to determine expenditures. They shall, however, manage the disbursement of Corporation funds as directed by the Knights Council Leadership Team or the President. In addition to these responsibilities, they shall perform the typical duties associated with the Treasurer's office and any other duties assigned by the Knights Council Leadership Team, Abaqua, His Divine Grace, or the President as required.

## ARTICLE 9: TRANSACTIONS OF THE CORPORATION

9.01. Contracts: The Knights Council Leadership Team has the authority to grant permission to any officer or agent of the Corporation, enabling them to enter into contracts or execute and deliver instruments on behalf of the Corporation. This authorization may pertain to a particular contract or instrument, or it may encompass a range of contracts and instruments, both in terms of quantity and type.

9.02. Deposits: All funds of the Corporation shall be deposited to the credit of the Corporation in banks, trust companies, or other depositories that the Knights Council Leadership Team or Abaqua, His Divine Grace, selects.

9.03. Gifts: The Knights Council Leadership Team or Abaqua, His Divine Grace, may accept any contribution, gift, bequest, or devise for the general purposes or for any special purpose of the Corporation.

9.04. Loans and Related Parties: The Corporation shall not make any loan to a Director or officer of the Corporation. However, the Knights Council Leadership Team shall allocate such sums as they deem necessary to cover the expenses of evangelism for Church Members and all expenses of Abaqua, His Divine Grace. The Knights Council Leadership Team will also authorize payments for the necessary contributions to support the growth of the Christian NeuroCosmical Philosophy contained in the Kingdom of Angels and the other books authored by Abaqua, His Divine Grace.

9.05. Prohibited Acts: As long as the Corporation is in existence, and except with the prior approval of the Board of Directors, no Director, officer, or committee member of the Corporation shall:

- (a) Do any act in violation of the Bylaws or a binding obligation of the Corporation.
- (b) Do any act with the intention of harming the Corporation or any of its operations.
- (c) Do any act that would make it impossible or unnecessarily difficult to carry on the intended or ordinary business of the Corporation.
- (d) Receive an improper personal benefit from the operation of the Corporation.
- (e) Use the assets of this Corporation, directly or indirectly, for any purpose other than carrying on the business of this Corporation.
- (f) Wrongfully transfer or dispose of property of the Corporation, including intangible property such as goodwill.
- (g) Use the name of the Corporation (or any substantially similar name) or any trademark or trade name adopted by the Corporation, except on behalf of the Corporation in the ordinary course of the Corporation's business.
- (h) Disclose any of the Corporation's business practices, trade secrets, or any other information not generally known to the business community to any person not authorized to receive it.
- (i) No member of the Church can assume the roles of doctor, sorcerer, or healer.

## ARTICLE 10: ACQUISITION AND DISPOSITION OF PROPERTY

10.01. Authority: No asset, real estate or otherwise, valued at more than 20% of the current approved operating budget, or \$500,000.00, whichever amount is lower, shall be purchased by the Kingdom of Angels Church, nor shall a contract to sell said major Kingdom of Angels Church assets be entered into unless the same is first approved by the Knights Council Leadership Team and confirmed by the Council of Overseers. Furthermore, the Knights Council Leadership Team, upon the advice of the Council of Overseers, has the authority to unilaterally accept major assets, including real property, valued in excess of the current approved operating budget if it is partially or entirely being donated, provided that it has clear title and that any funding used to augment the donation does not exceed available funding. Only Abaqua, His Divine Grace, can perform the acts described above at his sole discretion, without requiring more endorsement or consent than His wise decision, and then submit that act to the confirmation of the Knights Council Leadership Team.

10.02. Documentation: Title to all real property acquired by the Kingdom of Angels Church shall be deeded to the Kingdom of Angels Church Corp., and held in its name. Abaqua, His Divine Grace, and/or the Treasurer shall certify all documents relating to the purchase, sale, or lease of real property, and confirm that the same has been duly authorized in accordance with these Bylaws.

10.03. Property Status upon Division: In the event the Partners of Kingdom of Angels Church become divided over irreconcilable differences, all property of Kingdom of Angels Church shall remain with those Members, regardless of their number, whom the Council of Overseers and/or the Knights Council Leadership Team side with. The Council of Overseers shall be allowed to address the situation after due investigation. The Council of Overseers shall make a binding determination as to which Members are adhering to the Tenets of Faith and are in agreement with the Knights Council Leadership Team; those Members shall be deemed authorized to continue as Members under these Bylaws. The remaining Members shall then have their membership revoked.

10.04. Property and Asset Status upon Disaffiliation: The Kingdom of Angels Church shall not disaffiliate with the Affiliated Network without a decision of the Knights Council Leadership Team and confirmation by the Council of Overseers. Such proposal shall include a statement of the reasons for the proposed change in affiliation and be kept on file in the official minutes for access by any Member who desires to read it. Upon disaffiliation from an Affiliate Network, property owned by the Kingdom of Angels Church shall remain the property of the Kingdom of Angels Church.

#### ARTICLE 11: BOOKS AND RECORDS

11.01. Required Books and Records: The Corporation shall keep correct and complete books and records of account. The Corporation's books and records shall include:

- (a) A filed-endorsed copy of all documents filed with the State Secretary of State.
- (b) A copy of the Bylaws, and any amendments to the same.
- (c) Minutes of the proceedings of the Board of Directors, and of any committees having the authority of the Board of Directors.
- (d) A list of the names and addresses of the Directors, Members, and Officers of the Corporation.
- (e) A balance sheet for the three (3) most recent fiscal years.
- (f) An income statement for the three (3) most recent fiscal years.
- (g) All rulings, letters, and other documents relating to the Corporation's federal, state, and local tax status.

#### ARTICLE 12: SPECIAL PROCEDURES CONCERNING MEETINGS

12.01. Meeting by Electronic Means: The Board of Directors (the Knights Council Leadership Team), and any committee of the Corporation, may hold a meeting by telephone conference call or other electronic means in which all persons participating in the meeting can hear each other.

#### ARTICLE 13: AMENDMENTS TO BYLAWS

13.01. Amendments: The Bylaws may be altered, amended, or repealed, and new Bylaws may be adopted by the Knights Council Leadership Team upon confirmation of the Council of Overseers, or upon confirmation of Abaqua, His Divine Grace. The notice of any meeting at which the Bylaws are altered, amended, or repealed, or at which new Bylaws are adopted shall include the text of the proposed Bylaw Sections as well as the text of any existing sections proposed to be altered, amended, or repealed or a fair summary of those sections.

#### ARTICLE 14: MISCELLANEOUS

14.01. Legal Authorities Governing Construction of Bylaws: The Bylaws shall be construed in accordance with the laws of each State. All references in the Bylaws to statutes, regulations, or other sources of legal authority shall refer to the authorities cited, or their successors, as they may be amended from time to time.



14.02. Legal Construction: If any section of the Bylaws is held to be invalid, illegal, or unenforceable in any respect, the invalidity, illegality, or unacceptability shall not affect any other section and the Bylaws shall be construed as if the invalid, illegal, or unenforceable section had not been included in the Bylaws.

14.03. Dispute Resolution: Any controversy, claim, or dispute arising from or related to these Bylaws shall be initially settled through internal mediation among the Members of the Knights Council Leadership Team. If mediation is unsuccessful, the decision made by Abaqua, His Divine Grace, shall be considered final and binding in his infinite wisdom. The parties understand that these methods shall be the sole remedy for any controversy, claim, or dispute arising out of these Bylaws, and they expressly waive their rights to file a lawsuit in any civil court against one another for such controversies, claims, or disputes, except to enforce an arbitration decision.

14.04. Gender: Wherever the context requires, all words in these Bylaws shall encompass all genders and numbers.

#### ARTICLE 15: EMERGENCY POWERS AND BYLAWS

An emergency exists for the purposes of this section if a quorum of the directors cannot readily be obtained due to a catastrophic event. In such an emergency, the Members of the Knights Council Leadership Team may:

- (a) Modify lines of succession to accommodate the incapacity of any director, excluding Abaqua, His Divine Grace.
- (b) Relocate the principal office, designate alternative principal offices or regional offices, or authorize officers to do so.

During an emergency, notice of a meeting of the Members of the Knights Council Leadership Team (Board of Directors) need only be given to those directors whom it is practicable to notify, including by publication or radio. One or more officers of the Corporation present at a meeting of the Members of the Knights Council Leadership Team (Board of Directors) may be considered directors for the meeting, in order of rank and within the same rank and order of seniority, as necessary to achieve a quorum. Corporate action taken in good faith during an emergency binds the corporation and may not be the basis for imposing liability on any director, except Abaqua, His Divine Grace, or officer, employee, or agent of the Corporation on the grounds that the action was not authorized.


The Members of the Knights Council Leadership Team (Board of Directors) may also adopt emergency bylaws, subject to amendments or repeal by the full Board of Directors. These bylaws may include provisions necessary for managing the corporation during an emergency, such as:

- (a) Procedures for calling a meeting of the Board of Directors.
- (b) Quorum requirements for the meeting.
- (c) Designation of additional or substitute directors.

The emergency bylaws shall remain in effect during the emergency and shall be revoked after the Members of the Knights Council Leadership Team deem that the emergency has ended.
