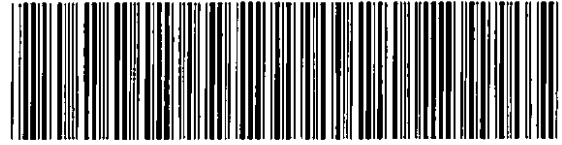

Articles Of Incorporation

Cynthia Brand Ministries Incorporation

(Florida Non-Profit Corporation)

THE UNDERSIGNED, each with the capacity to contract, hereby executes and acknowledges the Articles of Incorporation for the purpose of forming a corporation not for profit under and by virtue of the laws of the state of Florida. Pursuant to Chapter 617.0202, F.S.; the undersigned corporation submits the following information:

Article 1: Name of Corporation

The name of the corporation shall be Cynthia Brandt Ministries Incorporation.

Article 2: Address of Corporation

The Physical and mailing Address of the corporation in the city of Naples, Florida, is:

9524 Ironstone Terrace

Unit 102

Naples, FL 34120

Article 3: Shares

This is a non-stock corporation not authorized to issue stock.

Article 4: Purpose

The specific purpose for which this corporation is initially organized is to teach and preach the gospel to all people, conduct evangelistic activities, license and ordain ministers of the gospel, provide religious, charitable and humanitarian services, and also engage in activities that are necessary, suitable or convenient for the accomplishment of that purpose, or which are incidental thereto or connected therewith which are consistent with Section 501(c) (3) of the Internal Revenue Code. **This corporation is organized and operated exclusively for religious purposes within the meaning of Section 501 (c) (3), Internal Revenue Code.**

Article 5: Qualifications of Members

This corporation shall have no members.

Article 6: Terms and Dissolution

The commencement date of corporate existence shall be when these articles have been filed with the Division of Corporations and approved by it and the respective filing fee has been paid; the term for which the corporation is to exist shall be perpetual.

In the event of dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code or shall be distributed to the federal government, or state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by court competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

Article 7: Non-Profit Corporation

This corporation is organized and operated exclusively for religious purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code.

No Part of the net earnings of the corporation shall ever inure to the benefit of or be distributable to its members, directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in Article 4. No substantial part of the corporation's activities shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried out: (a) by a corporation exempt from federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law or: (b) by a corporation, contributions to which are deductible under Section 170 (c) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal revenue laws.

Article 8 Initial Registered Office and Agent

Article 9 Directors

The Board of Directors of the corporation shall consist of no less than (3) directors as determined by the Bylaws. Directors shall be appointed annually by the Directors.

The Board of Directors shall have the authority to provide reasonable compensation to its members for their services as directors and to fix the basis and conditions upon which this compensation shall be paid. Any director may also serve the corporation in any other capacity and receive compensation therefrom in any form.
