I affirm and declare that I am the Legal Representative and President of Encouragement Ministries, Corp. We erroneously filed as a for-profit corporation in August. On November 3<sup>rd</sup> I discovered this error and that day spoke with your people in Tallahassee.

I was told to dissolve the for-profit corporation and file as a non-profit under the same name. I did that immediately, and on Sunday I received confirmation that the old corporation was dissolved.

Today I received your letter saying that I could not file as a non-profit under that same name for 120 days. Since we need the registration as a non-profit to apply for an FCC radio license in the next few weeks, I called again today and was told that I need to print the Articles of Incorporation, and this affidavit declaring that we have no intention of revoking the dissolution of the previous for-profit corporation.

**So, I declare as the Legal Representative and President, according to our Articles of Incorporation, that we never intended to file as a for-profit corporation, and that we have no intention whatever of revoking the dissolution.**

We only want to be registered as a bona-fide non-profit organization in Florida with the name Encouragement Ministries, Corp. That's how we are registered with the IRS as a 501 3 c corporation.

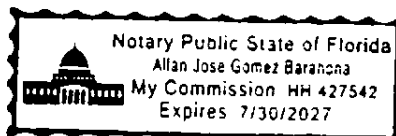
