**ARTICLES OF INCORPORATION OF RICHBURG LANE
STORMWATER AUTHORITY, INC., a Florida non-profit corporation**

The undersigned incorporator by these articles associates himself for the purpose of forming a corporation not for profit under the laws of the State of Florida, and adopts the following articles of incorporation:

ARTICLE I

NAME

The name of this corporation is Richburg Lane Stormwater Authority, Inc. For convenience, the corporation shall be referred to in this instrument as the "Association," these articles of incorporation as the "Articles," and the bylaws of the Association as the "Bylaws."

ARTICLE II

TERM OF EXISTENCE

The Association shall have perpetual existence.

ARTICLE III

CORPORATE PURPOSE

This association is organized for the purpose of providing a non-profit entity under the Florida Statute Chapter 617 (2023) ("the Statute") for the operation of the commercial association governing storm water runoff and retention for various parcels located in Okaloosa County, Florida.

ARTICLE IV

The method of election of directors is as stated in the Declaration of Drainage Easements, Covenants and Restrictions (the "Declaration") that will be recorded in the Public Records of Okaloosa County, Florida, and through which MH Crestview Land LLC, a Florida limited liability company, is the Declarant, as defined therein.

ARTICLE VII

MEMBERS

The qualification of members and the manner of their admission shall be as regulated by the Declaration.

DECLARATION

The association shall be initially governed by Declaration, which provides that Bylaws may be adopted for future governance.

ARTICLE X

STORMWATER MANAGEMENT SYSTEM


1. The Association shall operate, maintain and manage the stormwater management system in a manner consistent with the requirements of Northwest Florida Water Management District and applicable Agency rules together with the rules and requirements of applicable local governing authorities, and shall assist in the enforcement of the restrictions and covenants contained herein.
2. The Association shall levy and collect adequate assessments against members of the Association and other adjacent owners that have use rights and contribution obligations for the costs of maintenance and operation of the stormwater management system.
3. The assessments shall be used for the maintenance and repair of the stormwater management systems and mitigation or preservation areas, including but not limited to work within retention areas, drainage structures and drainage easements.
4. In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the stormwater management system must be transferred to and accepted by an entity which complies with Rule 62-330.310,

Florida Administrative Code, and be approved by the Agency prior to such termination, dissolution or liquidation.


