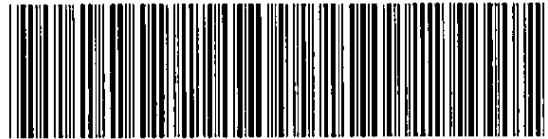

**ARTICLES OF INCORPORATION FOR ARCHANGEL RAPHAEL MINISTRY
CENTER, INC.**

Entity Information

I, the undersigned natural person over the age of eighteen (18), acting as an incorporator, adopt the following Articles of Incorporation of ARCHANGEL RAPHAEL MINISTRY CENTER, INC., (referred to as the "Corporation") under the Florida Non-Profit Corporation Act (referred to as the "Act"):

ARTICLE 1
NAME CHANGE

The name of the Corporation is ARCHANGEL RAPHAEL MINISTRY CENTER, INC.

ARTICLE 2
NON PROFIT CORPORATION

The Corporation is a nonprofit corporation. Upon dissolution, all of the Corporation's assets shall be distributed to one or more of the Coptic Orthodox medical clinics in the Coptic Orthodox Patriarchate - Diocese of Southern United States, organized and operated exclusively for medical and charitable purposes and qualifying as exempt from taxes under Internal Revenue Code Section 501(c)(3) for one or more purposes that are exempt under the Florida franchise tax. If upon dissolution no Coptic Orthodox medical clinic exists, the Corporation's assets shall be distributed pursuant to the Uniform By-Laws of the Coptic Orthodox Medical Clinics in the Coptic Orthodox Diocese of the Southern United States. In the absence of a Coptic entity, state law shall apply to the dissolution.

ARTICLE 3
DURATION

The Corporation shall continue in perpetuity.

ARTICLE 4
PURPOSES

The purposes for which the Corporation is organized are to perform charitable, education, scientific, and literary activities within the meaning of Internal Revenue Code and the Florida Tax Code. The Corporation shall be governed by the Uniform By-Laws of the Coptic Churches in North America.

ARTICLE 5 POWERS

Except as otherwise provided in these Articles, the Corporation shall have all of the powers provided in the Florida Business Organizations Statute. Moreover, the Corporation shall have all implied powers necessary and proper to carry out its express powers. The Corporation may pay reasonable compensation to directors, or officers for services rendered to or for the Corporation in furtherance of one or more of its purposes set forth above.

ARTICLE 6 RESTRICTIONS AND REQUIREMENTS

The Corporation shall have no power to take any action prohibited by the Florida Business Organizations Statute.

The Corporation shall have no power to take any action that would be inconsistent with the requirements for tax exemption under the Internal Revenue Code.

ARTICLE 7 MEMBERSHIP

The Corporation shall have no members. **The Trustees are appointed pursuant to Article 9 herein.**

ARTICLE 8 REGISTERED OFFICE AND AGENT

The street address of the **registered office and principal office** of the Corporation is 19800 Allaire Lane, Fort Meyers, Florida 33908. The name of the registered agent at this office is Father Joachim Boutros. **The principal place of business is the principal office with the address of 19800 Allaire Lane, Fort Meyers, Florida 33908.**

ARTICLE 9 BOARD OF TRUSTEES

The Corporation shall be governed by a Board of Trustees consisting of no less than three members. The Bishop of the Coptic Orthodox Patriarchate - Diocese of Southern United States and his successors in office, shall, by virtue of this office, be a Trustee of this Corporation. **Two or more persons selected by the Bishop** of the Coptic Orthodox Patriarchate - Diocese of Southern United States shall also be trustees of this Corporation, and the Bishop of the Coptic Orthodox Patriarchate - Diocese of Southern United States and the other such persons shall together constitute the Board of Trustees thereof. The Trustees of ARCHANGEL RAPHAEL MINISTRY CENTER, INC. shall exercise their powers in accordance with the rules, statutes, regulations and usages of the Coptic Church of Alexandria adopted by Synodical Committee for the Coptic Churches in Immigration, provided, however, that no act or proceeding of the

Trustees of this Corporation shall be valid without the approval of the Bishop of the Coptic Orthodox Patriarchate – Diocese of Southern United States in which the corporation is located, or, in case of his absence or inability to act, without the approval of the Vicar of such Diocese or Archdiocese and in addition to the Trustees, this provision includes officers and any other individual or group of individuals claiming to act on behalf of ARCHANGEL RAPHAEL MINISTRY CENTER, INC. The number of Trustees may be increased or decreased by adoption or amendment of bylaws. The Board of Trustees shall consist of the following persons at the following addresses:

ARTICLE 10 MANAGEMENT AND ADMINISTRATION OF BOARD OF DIRECTORS

The Board of Trustees shall appoint and renew the board of directors pursuant to the bylaws of the corporation and the board of directors shall consist of a minimum of one physician licensed in the state of Florida. The management and administration of the board of directors shall be consistent with the statutes and regulations of the state of Florida.

The Corporation shall take no action(s) contrary to the rules, statutes, regulations and usages of the Coptic Orthodox Church of Alexandria adopted by the Synodical Committee for the Coptic Orthodox Churches in Immigration, or contrary to the policies of the Bishop of the Coptic Orthodox Diocese of the Southern United States.

ARTICLE 11 LIMITATION ON LIABILITY OF TRUSTEES

A Trustee is not liable to the Corporation for monetary damages for an act or omission in the Trustee's capacity as Trustee except to the extent otherwise provided by a statute of the State of Florida.

ARTICLE 12 INDEMNIFICATION

The Corporation may indemnify a person who was, is, or is threatened to be made a named defendant or respondent in litigation or other proceedings because the person is or was a Trustee or other person related to the Corporation as provided by the provisions in the Act
