ARTICLES OF INCORPORATION OF
FLORIDA INDEPENDENT PHYSICIAN PRACTICE ASSOCIATION, INC.
A Florida Not for Profit Corporation**

ARTICLE I – NAME

The name of the Corporation shall be:

Florida Independent Physician Practice Association, Inc.

ARTICLE II – PRINCIPAL OFFICE

ARTICLE III – PURPOSE

The purpose for which the Corporation is organized is to promote and protect the high-quality, cost-efficient care furnished to patients in Florida in the independent medical practice setting, and in promoting the common interests of its members by engaging in activities permitted under Section 501(c)(6) of the Internal Revenue Code of 1996 (the "Code"), as amended, or the corresponding section of any future federal tax code.

ARTICLE IV – MANNER OF ELECTION

The manner in which the directors shall be elected and appointed shall be as set forth in the Corporation's bylaws.

ARTICLE V – ADDITIONAL PROVISIONS

18 No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to 2
its members, directors, trustees, officers, or other private persons, except that the Corporation 3
shall be authorized and empowered to pay reasonable compensation for services rendered and to 4
make payments and distributions in furtherance of the purposes set forth in Article III of these 5
Articles of Incorporation. 6


Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(6) of the Code, or the corresponding section of any future federal tax code.
