

## ARTICLES OF INCORPORATION AND OF STATE

In compliance with Chapter 617, F.S., (Not for Profit) LLAHASSEE, FL

#### ARTICLE I: NAME

The name of this corporation shall be Mosaic of Faith Inc. with its principal business address located at: 1909 Violet Avenue Suite 3, West Palm Beach, Florida 33415.

#### ARTICLE II: DURATION

The period of duration of the corporation is perpetual.

#### ARTICLE III: PURPOSE

Mosaic of Faith Inc is a non-profit corporation and shall operate exclusively for religious, educational, and charitable purposes including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, including the publishing or distribution of statements, any political campaign on behalf of any candidate for public office.

Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### ARTICLE IV: MANNER OF ELECTION

The manner in which the directors are elected or appointed is provided in the bylaws of the corporation.

#### ARTICLE V: OFFICERS
