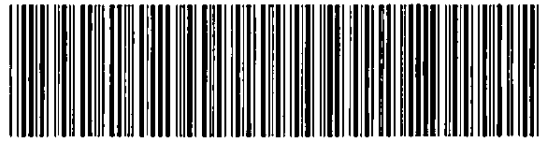

ANITA RAI SEVA FOUNDATION, INC. is a non-profit corporation and shall be operated as a private operating foundation, for educational, medical and charitable purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, or the corresponding section of any future Federal tax code.

The specific purposes of the Corporation is devoted to bring people (of any race, ethnicity and cultural-/ religious background

together to meet, create, and celebrate, to provide a space for these individuals, groups and organizations to book and gather for activities (celebratory receptions, trainings, conferences, lectures, seminars, etc.), hereby hoping to foster a safe and vibrant community that will further serve the community as a whole. It also seeks to promote the work of creatives in the community by offering an artistic platform such as gallery space, concert venue, et al.

To maximize our impact on current efforts, we may seek to collaborate with other non-profit organizations which fall under the 501(c) (3) section of the internal revenue code and are operated exclusively for religious, medical, educational and charitable purposes.

At times, per the discretion of the board of directors, we may provide internships or volunteer opportunities which shall provide opportunities for involvement in said activities and programs in order to have a greater impact for the change.


