



Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under the section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: Our organization is dedicated to nurturing entrepreneurship from a young age, empowering aspiring entrepreneurs to embark on a clear path to success. By providing comprehensive support and guidance, we aim to equip individuals with the knowledge, resources, and skills needed to build thriving businesses, ensuring they make informed decisions and avoid wasting precious time.
