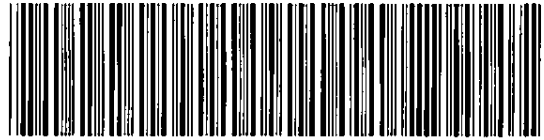

Dissolution of Assets Provision-upon the dissolution of New Dimensional Outreach Community Development Corporation, assets shall be distributed for one or more exempt purposes within the meaning of

Section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code or shall be distributed to the federal government or to a state or local government for a public purpose. Any such assets not disposed of by a court of competent jurisdiction in the county in which the principal office of New Dimensional Outreach Community Development Corporation is located, exclusively for such purposes or to such organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
