

Articles of Organization

Of

Fair Admissions @ MIT, Inc.

Article One

The name of the corporation is Fair Admissions @ MIT, Inc. (the "Corporation").

Article Two

The principal office of the Corporation shall be located at 2465 Mclin Ln., The Villages, Florida, 32163.

Article Three

The purpose of the Corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of Florida. The specific purpose for which the Corporation is organized is to defend and promote civil liberties and human and civil rights, including equal protection under the law through litigation and other lawful means.

The Corporation shall have no members.

The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The Corporation shall not be operated or conducted for profit, nor shall any of the revenues or assets of the Corporation be used other than for the purposes of the Corporation. No part of the revenues or assets of the Corporation shall inure to the benefit or be distributed to its

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles of organization, the Corporation shall not carry on any activities not permitted to be carried on by an organization (i) exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future tax code, or (ii) by an organization contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The duration of the Corporation shall be perpetual. In the event of liquidation, dissolution, or winding up of the Corporation, whether voluntary, involuntary, or by operation of law, the property and assets of the Corporation remaining after payment, satisfaction and discharge of liabilities and obligations, shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.

Article Four

The officers and directors shall be chosen in accordance with the Bylaws of the Corporation.
