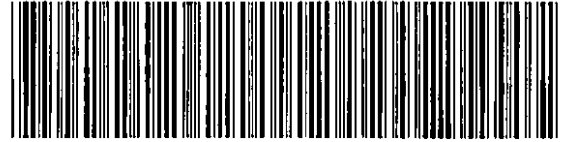

ARTICLE VI (Amend B)

B) This not for profit corporation shall further function and operate as a Florida not for profit corporation specifically for the following purposes and objectives:

1. To engage, inform, connect and coordinate community-focused programs and services that enhance quality of life.
2. To offer programs and services to all regardless of race, ethnicity, socio-economic status, or religious affiliations that will

increase self-worth, assure supportive aging-in place, and enrich the lives of teens, families, seniors and communities.

3. To serve all in a caring and safe environment.

4. To listen to the community in order to take care of the needs of the community.

ARTICLE VII (Amend)

(Keep paragraph 1:) No officer or member of the Board of Directors of this not for profit corporation shall receive any pecuniary profit from the operation of the not for profit corporation, except in furtherance of the purposes set forth herein...

(Delete Paragraph 2:) This not for profit corporation shall exist perpetually or exist until dissolved by due process of the law..

(Add:) The property of this not for profit corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of the corporation shall ever inure to the benefit of any director, officer or member or to the benefit of any private person.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations described under Section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government for a public purpose.
