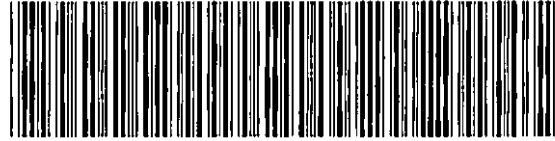

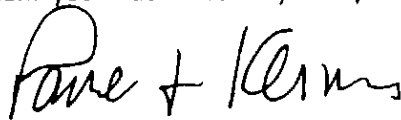
The attached application to incorporate (in two copies) is forwarded for your necessary action in accordance with Chapter 617.0202, Florida Statutes.

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME: Cypress Village Scholarship Fund, Inc.

ARTICLE II PRINCIPAL OFFICE: 4600 Middleton Park CR-East Box C-140, Jacksonville, FL 32224

ARTICLE III PURPOSE: The Corporation shall be operated to generate, invest, and disburse funds in support of scholarships to employees of Cypress Village Retirement Community and / or other designated individuals who are pursuing education through accredited schools or programs. Instruction may be full-time or part-time via in-person classes, on-line courses, or a combination of these delivery methods. Scholarships may cover application fees. Tuition, books, study materials, lab fees, and related expenses required by the school or training facility.

ARTICLE IV MANNER OF ELECTION: Officers and Directors from the predecessor Cypress Village Scholarship Fund shall serve in similar positions with the Corporation. There is no specified term of office. If the President resigns or is unable to continue his/her duties and the other Officers and Directors are unable to agree on a successor, they may request assistance from the President of the Cypress Village Retirement Community Residents Advisory Council. Corporate Officers and Directors may serve until they resign or are otherwise unable to perform their duties. Officers and Directors may be terminated from their positions by the President for good cause or for conduct prejudicial to the best interests of the Corporation.
