

## PINE MANOR IMPROVEMENT ASSOCIATION, INCORPORATED BYLAWS

#### ARTICLE I - NAME

The name shall be the Pine Manor Improvement Association, Incorporated.

#### ARTICLE II - OBJECT

The object of the Pine Manor Improvement Association, Incorporated shall be:

<u>Section 1</u>. To promote community input and open the lines of communication between residents and property owners of Pine Manor.

<u>Section 2</u>. To improve the standards of living for residents of Pine Manor through member participation in community projects.

<u>Section 3.</u> To offer a means by which residents may interpret and promote programs of county, state, national and international importance in the preservation of the American community, neighborhood and home.

#### ARTICLE III - MEMBERSHIP

- Section 1. Membership to the Pine Manor Improvement Association, Incorporated, shall be extended to any person who pays dues.
- Section 2. The Pine Manor Improvement Association, Incorporated does not discriminate by sex, race, color, age, handicap, religion or national origin.
- Section 3: Full voting privileges shall be extended only to those members who live in or own property in the Pine Manor Neighborhood.

#### ARTICLE IV - OFFICERS AND ELECTIONS

- <u>Section 1.</u> The elected officers of the Pine Manor Improvement Association, Incorporated shall be President, Vice-president, Secretary and Treasurer.
- Section 2. The four elected officers, three to five at-large voting members, and the retiring President, shall comprise the Board of Directors. The retiring President shall serve as advisory member of the Board of Directors without vote for the succeeding year.
- Section 3. Articles in the Bylaws pertaining to the election shall be read to the voting members before each election.
- Section 4. The Board of Directors shall be elected for a one year term. Elections will be held in November of every year. Officers may serve consecutive terms in the same office.

<u>Section 5.</u> The Board of Directors shall be responsible for making appointments to fill any offices vacated. The appointments shall be for the remainder of the unexpired term.

<u>Section 6.</u> The Board of Directors may present the name of two persons for office following the guidelines for eligibility:

- (a) A nominee for any office must be a voting member of the Pine Manor Improvement Association, Incorporated
- (b) Nominations may be made from the floor by voting members.

<u>Section 7.</u> All new board members, appointees or officers voted into office for their first term are required to create and implement one project for the Pine Manor area within the year following their appointment.

<u>Section 8.</u> Once board members, appointees or officers miss two consecutive meetings without calling an elected officer with a reason for their absence, they will relinquish their seat, and a new person will be elected by the general membership.

#### ARTICLE V - DUTIES OF OFFICERS

<u>Section 1.</u> The President shall preside at all business meetings of the Pine Manor Improvement Association, Incorporated and of the Board of Directors and perform such other duties as are described in these Bylaws and the parliamentary authority adopted by the Pine Manor Improvement Association, Incorporated

(a) The immediate Past President shall serve as an advisory member of the Board of Directors without vote for one year following the end of her/his term as President.

Section 2. The Vice-president shall assist the President and perform all assigned duties during the term of office; serve with vote on the Board of Directors and serve as chairman of the Bylaws Committee. The Vice-president shall perform all duties of the President in his/her absence or disability.

Section 3. The Secretary shall keep a record of the minutes of the Pine Manor Improvement Association, Incorporated, and the Board of Directors and shall attend to correspondences.

<u>Section 4.</u> The Treasurer shall have charge of all funds of the Pine Manor improvement Association, incorporated, and shall pay them out on order of the President; and shall make a Treasurer's report monthly at the association meeting. The Treasurer's books shall be examined annually by the Board of Directors.

The Treasurer shall submit any and all forms required by the Internal Revenue Service for non-profit corporations and any required by the State of Florida on or before the required date.

#### **ARTICLE VI - MEETINGS**

<u>Section 1.</u> The Pine Manor Improvement Association, Incorporated shall have monthly meetings. The place and time is designated by the Board of Directors. At all business meetings of the Pine Manor Improvement Association, Incorporated the voting members present shall constitute a quorum.

Section 2. The Board of Directors of Pine Manor Improvement Association, Incorporated shall have monthly meetings to discuss general meeting agenda items.

#### **ARTICLE VII - FINANCES**

Section 1. Each member belonging to the Pine Manor Improvement Association, Incorporated shall pay into the treasury annual dues on membership as of January 1 or semi-annual dues as of July 1. The amount shall be recommended by the Board of Directors and passed by the Pine Manor Improvement Association, Incorporated.

Section 2. All annual dues shall be due and payable January 1, and shall be delinquent after March 1. All semi-annual dues shall be due and payable July 1, and shall be delinquent after September 1.

#### **ARTICLE VIII - AMENDMENTS**

Section 1. These Bylaws may be amended at any monthly meeting by a two-thirds vote of the voting members attending, provided notice of the proposed amendment has been sent to the members THIRTY (30) days prior and providing the amendment has been read at two business meetings of the Pine Manor Improvement Association and voted on immediately following the second reading.

<u>Section 2.</u> Standing Rules shall be reviewed at least once during each President's term by the Pine Manor Improvement Association Board of Directors.

#### ARTICLE IX - PARLIAMENTARY PROCEDURES

Standard rules of parliamentary procedure shall be used at the meetings of the Pine Manor Improvement Association, Inc. and the Board of Directors. The President of the Pine Manor Improvement Association, Inc. shall have the parliamentarian authority.

#### ARTICLE X - NON-PROFIT STATUS

The Pine Manor Improvement Association, Incorporated is a non-profit organization. Any funds received by the organization for carrying out its purpose shall not accrue to the benefit of individual members.

#### NOTICE OF PROPOSED BYLAW AMENDMENTS

Article III – Membership Section 3: to be deleted to allow any dues paying member, whether they live or own property in Pine Manor, full voting rights.

Article IV - Officers and Elections Section 2: to be revised to allow 5-7 at large board members and to delete responsibilities of retiring president.

Article IV - Officers and Elections Section 6: to be revised to read "At the annual elections..." at the beginning of the section for clarification.

Article IV - Officers and Elections Section 7: to be revised in the deletion of first term and the rewording of "required to create and implement one project...within the year..." to "required to participate in community projects and attend monthly meetings."

Article V - Duties of Officers Section 1 Sub (a): to be deleted to release the retiring president of responsibility.

Article VII - Finances Section 1: to be revised to simplify dues being renewed one time a year for the calendar year.

Article VII - Finances Section 2: to be deleted so there are no delinquent dues

Article XIII - Amendments Section 2: to be revised to change "Standing rules.." to "Bylaws..."

<u>Section 6:</u> At the annual elections, the Board of Directors may present the name of two persons for office following the guidelines for eligibility:

- (b) Nominees may be made from the floor by voting members.

<u>Section 7:</u> All new board members, appointees or officers voted into office are required to participate in community projects and attend monthly meetings.
