ARTICLE III

PURPOSES

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from federal Income Tax Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

The purpose for which the corporation is organized is specifically to provide residential services, food, transportation, recreation, training in social self-help skills supervision, and all other services necessary and incidental to the operation of a group home or homes, for clients of the Florida Department of Health and Rehabilitative Services, or participants in the Florida Optional State Supplementation Program or other individuals in need of such services.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
