The Articles of Incorporation of THE PINELLAS CENTER FOR THE VISUALLY IMPAIRED FOUNDATION, INC. is hereby amended as follows:

1. Article One is hereby deleted and the following is inserted in lieu thereof:

ARTICLE ONE

The name of the corporation is changed as follows:

2. All amendments included herein were adopted pursuant to Section 617.0124, F.S., and there is no discrepancy between the Corporation's Articles of Incorporation as theretofore amended other than the inclusion of these amendments and the omission of matters of historical interest.

3. This Amendment has been approved by unanimous consent of all of the members of the Corporation who are entitled to vote and was adopted by said members on the 23rd day of July, 2000. The number of votes cast for the amendment was sufficient for approval. *25th gmn*

4. This Amendment shall be effective upon its filing with the Secretary of State, State of Florida.
