ARTICLES OF INCORPORATION OF

SARA MANA ANTIQUE DEALERS ASSOCIATION, INC.

(A Corporation Not for Profit under the Laws of Florida)

Pursuant to the Articles of Incorporation and Bylaws, the following provision of the Articles of Incorporation of Sara Mana Antique Dealers Association, Inc., shall be amended: Article Three, entitled "Purpose" and said Articles of Incorporation shall be amended to add a new Article Twelve, entitled "Dissolution Clause".

Article Three is hereby deleted and the following is substituted therefor:

ARTICLE THREE

<u>Purpose</u>

The corporation is organized exclusively for charitable, educational, religious, or scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

ARTICLE TWELVE

Dissolution Clause

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the Federal government, or to a state of local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

The foregoing Amendments were adopted by the act of the members of the corporation and adopted in the manner provided in the Bylaws of the corporation on the 26 day of October ,2001.
