ARTICLE 9

DIRECTORS

9.1 Number and Qualification. The property, business and affairs of the Association shall be managed by a board consisting of the number of directors determined in the manner provided by the By-Laws, but which shall consist of not less than five (5) directors. Directors must be a record title owner or a spouse of a record title owner of a Residential Unit in the Condominium. In addition to the foregoing, if record title to a Residential Unit is in the name of a Trust or a business entity, an individual may only serve as a Director if he or she is the trustee or beneficiary of such Trust, or the spouse of the trustee or beneficiary of such Trust, or an officer/member/partner of such business entity, or the spouse of an officer/member/partner of such business entity.
