

Pursuant to the provisions of §617.1403 of the Florida Not-For-Profit Corporation Act, the undersigned corporation adopts the following Articles of Dissolution for the Purpose of Dissolving the Corporation:

1. The name of the corporation is FAITH COMMUNITY CHURCH OF MIAMI, INC.
2. Dissolution was authorized on October 12<sup>th</sup>, 1999.
3. The corporation has no members or members with voting rights.
4. The date of adaption of the resolution by the Board of Director was October 12<sup>th</sup>, 1999.
5. The number of Directors and Officers were three and the vote on the resolution was 3 in favor and 0 against.
6. All liabilities and obligations of the corporation have been paid or discharged.
7. All the property and assets of the corporation remaining after the payment of all debts, obligations and liabilities of the corporation, have been distributed exclusively for charitable, scientific or education purposes.
8. There are no actions pending against the corporation in any court.
