## ARTICLE I

Amend as follows:

The full name of the corporation is,  
CHRISTIAN CONGREGATION IN THE UNITED STATES,  
(TAMPA LOCALE INC.)

## ARTICLE III

Amend as follows:

Said incorporation is formed exclusively for religious purposes: To wit, the worship of Almighty God according to the Apostolic age writings that constitute the New Testament in the Holy Scriptures, and the proclamation of Christian Faith among those in whatever land who have not earlier received it. The Corporation is poised to exercise rights and privileges conferred on a NON-PROFIT corporation by law, and only those within the law, including the power to own, dispose of, or contract for use of real or personal property, as deemed necessary or desirable for attaining the corporation's objectives. The corporation will not, except possibly inadvertently and to an insubstantial degree, be engaging in any activities or exercising any powers that are not in furtherance of the aforestated purposes.

## ARTICLE IV

Amend as follows:

The Corporation has one class of members: those who sincerely accept the Faith and Doctrine of the Christian Congregation in the United States and firmly adhere to its teachings in their personal lives, walking in "newness of life" as the Scriptures require and continuing therein.

## ARTICLE V

Amend as follows:

Income to the corporation regularly takes the form of voluntary contributions by the members, as deposited in the collections that are scheduled and announced.

No church official receives compensation for his office.

No church official receives compensation for his office.

The corporation does not involve itself or its means in changing the social order within a nation , nor in promoting or influencing legislation, nor in supporting or opposing political candidates, office holders, or political parties.

The corporation does not have ties or formal association with other religious organizations, affiliating only with the churches of the same name and Faith.

## ARTICLE VI

Registered office and Agent

The registered office of this corporation shall be 2217 Clement Rd. Lutz, Florida 33549 , and the name of the registered agent of this corporation is James Amodeo

Amend as follows:

The By-Laws of the corporation have been duly adopted. The Administration of the church , responsible for administering its corporal matters, is made up of a Chairman , and associate Administrators. The directors will be appointed by the elders as stated in the By-Laws.

## ARTICLE XV

Amend as follows:

### Dissolution of Corporation

No part of the receipts of the corporation will inure to the benefit of any member or official: notwithstanding, the corporation may contractually pay for work performed or material services rendered, whether by members or non-members.

Should the corporation or a segment of it undergo dissolution, the corporate assets will not accrue to any member(s) or official(s). But rather, after discharging all liabilities, will revert to remaining churches of this name and convention having the identical religious purpose and objectives.
