**ARTICLES OF DISSOLUTION

**ARTICLE I**

The name of this corporation is The Innlet at Ponte Vedra Beach Master Association, Inc., a Florida not-for-profit corporation. (the "Corporation").

**ARTICLE II**

The Articles of Incorporation of the Corporation were filed on December 18, 1987 and assigned Document Number N23977.

**ARTICLE III**

The authorization date of the dissolution was as of November 8, 2018.

**ARTICLE IV**

The dissolution of the Corporation was authorized by resolutions adopted by the Members of The Innlet at Ponte Vedra Beach Condominium Association, Inc., and the Members of the Ponte Vedra by the Sea Homeowners Association, Inc., both of whom authorized the Board of Directors to dissolve the Corporation. The dissolution of the Corporation was then authorized by resolutions of the Board of Directors of the Corporation on November 8, 2018. The number of votes cast by the members of each entity and the Board of Directors of the Corporation for dissolution was sufficient for approval.

**ARTICLE V**

The Board of Directors of the Corporation authorized the transfer of all assets of the Corporation to the Ponte Vedra by the Sea Homeowners Association, Inc., which also agreed to assume and pay all liabilities of the Corporation.

**ARTICLE VI**

The dissolution of the Corporation shall be effective as of the date of filing.
