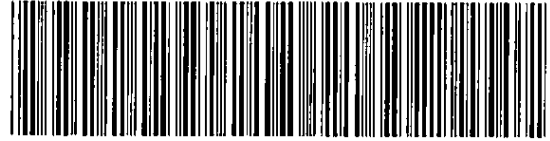

Article III The specific purpose for which this corporation is organized is:

ROMANIAN ORTHODOX CHURCH

"St Paisius of Neamtz Romanian Orthodox Church Inc. is organized as a Parish of the Romanian Orthodox Metropolia of the Americas. The purpose is to proclaim and teach the Gospel in accordance with the Christian faith; sanctify the faithful through God's grace in worship, the Divine Liturgy and the other sacraments; enhancing its parishioners' spiritual life,

and add to the numbers of the faithful by receiving persons into the Church through instruction and baptism.

In addition, it shall establish educational and philanthropic activities to foster the aims and mission of the Parish and to edify its parishioners in the faith and ethos of the Orthodox Church. It is organized exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code."



Article VIII Other Provisions :

"No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

The Statutes for the Organization of the Romanian Orthodox Metropolia of the Americas, as approved by the Archdiocesan Congress, shall function as the operating By Laws of the corporation."
