ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)
State of Florida, U.S.

ARTICLES 1. NAME The name of the corporation shall be: New Covenant Ministries International, Inc.

ARTICLE II. PRINCIPAL OFFICE Principal address (street and mailing) of said corporation is

435 South Villa San Marco Drive Unite 203, Bldg 5 St Augustine, FL 32086

ARTICLE III. PURPOSE The purposes of this corporation shall be as for operate exclusively for religious, charitable, educational and distinct ecclesistical purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code 1951 as amended, or any superseding statute thereto, and such purposes shall include the following:

- (A) Religious
- (B) To form a fellowship of like-minded people who preach the Word of God and to provide spiritual covering for ministers associated with New Covenant Ministers International, Inc.
- (C) To conduct a local church and churches by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit in accordance with all of the commandments and provisions as set forth in the Holy Bible, the irrevocable Word of God. Pursuant thereto, the following activities and guidelines shall be established:
- (1) A recognized Creed, Code of Doctrine, discipline and form of worship shall be established.
 - (2) An ecclesiastical form of government shall be established.
- (3) Ordination of ministers upon completion of the prescribed course of study, designated by this religious organization.
- (4) An organization of ministers shall be established to minister to the congregation of New Covenant Ministries International, Inc., and all churches in fellowship and/or affiliated with New Covenant Ministries International, Inc.

- (5) Spread the Word of the Gospel through seminars, radio, television, World Wide Web, establishment of church literature, and other forms of mass media for the purpose of educating the individual in the Word of God.
- (6) Establishment of various religious services pursuant to the recognized Creed, form of worship, code of doctrine and discipline of the church and the establishment of Sunday schools and religious schools for Christians and educational instruction to the young and to the old.
- (7) Establishment of a Bible Training School or School of Theology or Bible Colleges/Universities for the preparation of ministers who will be ordained and/or minister to the local church or churches, lay ministers and/or people in general who want/desire a solid Bible school/college education and anyone else who is in affiliation with New Covenant Ministries International, Inc.
- (8) Minister the Word of God to the faithful and all others.
- (9). Promote and encourage, through the ministry of the organization, cooperation with other organizations ministering within the community and all other areas both domestic and internationally.
- (10) To acquire and hold such property, either real or personal, for religious purposes, as may be necessary for its membership, the worship of God and the purposes Covenant Ministries International, Inc.

In accordance with and in addition to the powers conferred by the laws of the State of Forida the Non-Profit Corporation shall have the following powers:

- (a) To receive and accept gifts of money and property and to hold the same for any of the purposes of the Corporation and its work.
- (b) To raise and assist in raising funds for the purposes herein set forth, including the issuance of bonds or other instruments of credit.
- (c) To acquire, own, lease, mortgage, and dispose of property, both real and personal.
- (d) To conduct and carry on religious services and instruction through the public media, including electronic broadcasting, AM and FM radio, telecasting, microwave distribution, closed circuit transmission, cable television, and World Wide Web.
- (e) To acquire, own, and operation such radio/television broadcasting and/or telecasting facilities and/or a World Wide Web site.
- (f) To issue annuities and to enter into gift-annuity contracts.
- (g) To accept property and donations in trust for religious or charitable purposes or to perform any of the above purposes of said organization.

(h) To acquire, hold, own, sell, assign, transfer, mortgage, pledge, or otherwise dispose of shares of the capital stock, bonds, obligations or other securities of other corporations, domestic or foreign, as investments or otherwise, in carrying out any of the purposes of the Corporation and, while the owner thereof, to exercise all rights, powers and privileges of ownership, including the power to vote thereon.

ARTICLE IV. MANNER OF ELECTION. The manner in which the directors are elected and appointed will be as stated in the bylaws of New Covenant Ministries International, Inc. The current Officers and/or Directors/Trustees will remain and be known as the Corporate Board of Trustees and as such serve therein and shall hold their offices indefinitely and so far as may be until their lifestyle deems otherwise. In the event of the inability of any trustee to act, or in the event of the death of any trustee, the remaining trustees shall elect another trustee, or trustees, to fill the vacancy or vacancies, thus created.

ARTICLE VI. NOT FOR PECUNIARY GAIN New Covenant Ministries International inc. is not organized for pecuniary gain or profit, nor shall it have any power to issue certificants of stock or declare dividends, and no part of its net earnings shall inure to the benefit of any members, directors, trustees, or individuals, except that New Covenant Ministries International, Inc. shall have authority and be empowered to pay and to be paid a reasonable compensation or services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of New Covenant Ministries International, Inc. shall be the carrying on of propaganda or otherwise attempting to influence legislation, and New Covenant Ministries International, Inc. shall not participate in or intervene in (including the publishing or distribution of statements) a political campaign. Notwithstanding any other provisions of these Articles, New Covenant Ministries International, Inc. shall not carry on any other activities not permitted to be carried on by:

- (a) A corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law) or,
- (b) A corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue law.

ARTICLE VII. DISSOLUTIN. In the event of the dissolution of the corporation, or in the event it shall cease to carry out the objectives and purposes herein set forth, all of the business, property and assets of the corporation shall go and be distributed to such non-profit corporation qualifying as an organization exempt under the provisions of Section 501 (c) (3) of the Internal Revenue Code of 1954, as amended, or any superseding statute thereof, and as an organization qualifying as a public charity under the provisions of Section 509 (a) (2) of the Internal Revenue Code of 1954, as amended, or any superseding statue, as the Directors or Trustees of the corporation may select and designate; and in no event shall any of said assets or property, in the event of dissolution thereof, go or be distributed to members, either for the reimbursement of any sum subscribed, donated or contributed by such members, or for any other such purpose. Any such assets not so disposed of shall be disposed of by the District Court of the County in which the principal office of the corporation is located, exclusively for such purposes, or the organizations as said court shall determine, which are organized and operated exclusively for such purposes.
