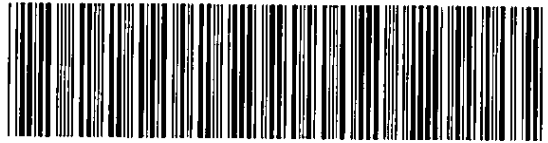

(Not for Profit)
OF

Article I – Name

The name of the Corporation shall be Universal Banquet, Inc.

Article II – Address of Corporation

Article III - Purpose

The purpose for which this Corporation is to advance the religion of Christianity and to open up those who are poor in spirit or mind to the Word of God. 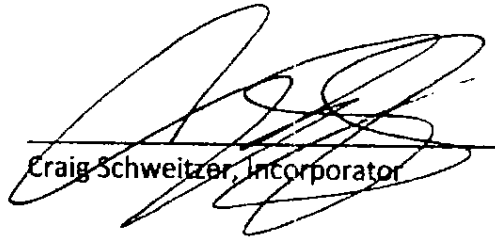
