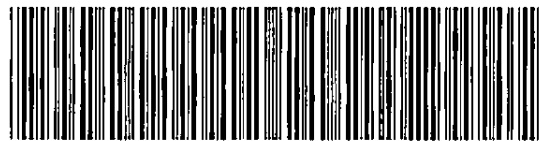

The purpose of forming the Boat Ecology Tech Research Ideas Inst. is to advance research and design technology to develop economical, waterbourne, human habitat construction systems that may be used by the ocean science sector, commercial recreation sector and the private sector. The goal is to design improved live aboard vessels for the marine-based industry and expand on an adaptation for coastal living people faced with sea level rise and other threats due to the climate change crisis upon conventional near-shore buildings that have failed to protect communities and infrastructure in this new, global reality. In addition, and unlike existing marine vessels, the BETR prototype boats will aim to innovate a better way of making boats to be much less expensive to purchase as well as much less costly to maintain by adopting some improvements already in practice in the architectural standards of land-base structures, incorporating Americans with Disabilities Act (ADA) guidelines, promote the use of the more appropriate materials throughout the structure and improve the energy efficiency of the living space to name a few. And given the harsh demands of a marine environment we shall also

aim to reduce and perhaps remove many of the corrosive problems caused by salt air above the waterline and the need of toxic anti-fouling paint below the waterline, eliminating the burden of hauling out the vessel to dry dock, typically on an annual schedule, entirely. B.E.T.R. Ideas Institute hopes to manifest innovations toward a better, healthier, harmonious way to enjoy life on the water on our special water planet!

Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.


