Attachment to the Articles of Incorporation of Sponsor a Pet Foundation Inc Article III "Purposes"

H240000066313

This corporation is established exclusively for charitable purposes within the meaning of the IRC sec 501(c)(3), namely: to prevent cruelty to animals in the State of Florida or elsewhere by advocating for the adoption of animals that are housed in shelters, that have been abandoned, or that suffer from neglect or abuse on the part of inhuman or ignorant owners. This corporation will undertake activities to give these animals a chance at finding new forever homes. It will plan and implement events, programs, courses and seminars to raise awareness concerning the importance of animal/human relationships, and how such relationships can help heal broken hearts and minds. It will teach about the importance of animal rescue and the paths available for adoption into a forever homes. It will help adoptive families to adequately prepare for pet adoption, as many animals are abandoned each year because people are not prepared for the amount of time or money required to care for them. It will strive to increase the number of people willing to foster rescued animals thereby decreasing the number of animals that are euthanized due to under-funding and over-crowding. It will focus on improving shelter conditions, preventing mistreatment of animals, and preserving natural habitats. It will strive to meet the basic needs of animals by providing offering food, medicine veterinary care, and by finding safe, loving families. Using online resources, it will share uplifting stories about the achievements of animal advocates. It will operate an online community for animal lovers to celebrate victories, recognize rescuers, and stay connected through periodic email updates.

This corporation will not attempt to influence legislation or participate in political campaigns of any sort. No part of the earnings of this corporation will interest for the benefit of its directors or officers and it will not distribute dividends to anyone. However, it will pay reasonable compensation for services provided, work done, resources purchased, or properties acquired in order to carry out its mission. It will rent or purchase real property in order to provide suitable facilities for its activities.

Upon the filing of these articles with the Secretary of State, the Directors will be empowered to adopt bylaws and other related documents, to appoint corporate officers, to file forms with government agencies and to undertake any other action required for the operation of this corporation. The directors will adopt such decisions through in person meetings, telephonic communication, meetings via

electronic media, written and signed consent, as well as by virtual signatures, all of which will be seen as equivalent to a vote cast at a meeting. Replies sent from emails belonging to directors or messages via any form of electronic communication belonging to directors, shall be seen as written signed consent to the proposal contained in the communication that is being replied to, and the equivalent of a vote cast at a meeting of the directors. The Directors and Officers of this corporation are hereby given the authority, both individually or in pairs, to open accounts and serve as signatories on behalf of this corporation in any banks, branches or financial institutions that shall be deemed appropriate.

In the event of this corporation's dissolution, the directors will –after clearing all debts and liabilities— distribute any remaining funds or assets to other charitable organizations recognized by the IRS under section 501(c)(3) that have similar purposes.
