Attachment to Articles of Incorporation of Florida Riptide Inc.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that quality as exempt organizations under the section 501 (c) (3) of the Internal Revenue? Code, or corresponding section of any future federal tax code. The business activity for said organization is as follows: We are a youth travel baseball team looking to expand our opportunities to raise money for our team. Several business have offered to donate money to our boys but they are only able to donate to proper 504c3 non-profit organizations.

No part of the net earnings of this organization shall mure to the benefit of, or be distributable to, its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.
