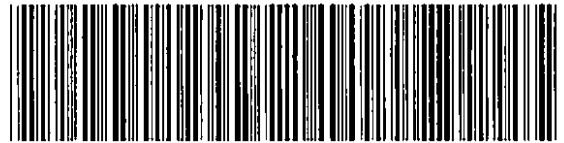

Purpose and Dissolution Clause as required by IRS:

Purpose Clause:
