

Article : Purposes for which the Corporation is organized:

- 1. To promote, manage and run a program for entrepreneur development especially women and promote, manage and run accommodations for trainees especially women undergoing such entrepreneur development programs and also promote and run any trade/business or industry for generating employment creating wealth and prosperity and to attain emancipation and equality through empowerment.
- 2. To provide training and guidance in all aspects of setting up and running a venture for potential and existing entrepreneurs, educated, unemployed, low income and under privileged groups, women and others to help and assist them by imparting training and guidance in all matters relating to industry and business such as motivation, management, finance, production, marketing, technology, accounts, labor laws, commercial laws, taxation laws etc. within and outside Illinois.
- 3. To set up training centers for entrepreneurship development at various places within and outside . History 1990
- 4. To conduct market surveys, workshops, conferences, etc. for any institutions or groups of individuals directly associated with politics and programs of entrepreneurship promotion and development.
- 5. To run technical workshop, laboratories and industrial clinics for training, counseling of potential and existing entrepreneur and for conducting research and dissemination of information.
- 6. To provide consultancy independently and in association with another institution, agency related to entrepreneur organizing and conducting entrepreneurship development programs within or outside Illinois.
- 7. To conduct or sponsor research and to undertake or sponsor research in the techniques for small business development or industry in the field of entrepreneurship development.
- 8. To co-ordinate with various financial institution for providing the project costs and working capital to the entrepreneur.
- 9. To publish books, journals, informational materials for training in entrepreneur development program and technology and management development.
- 10. To conduct any programs in co-ordination with the state, federal government or other industrial organization in furtherance on the objects of the Institute.

Article 5: Other provisions:

- 1. The income and property of the Institute shall be applied towards the promotion of the objects set forth in the Articles of Organization subject in respect of grants made by the State or Federal government, to such limitations as the Government may from time to time, impost. No portion of the income and property of the Institute shall be paid or transferred directly or indirectly by way of dividends, bonus or otherwise howsoever by way of profits to the present persons who may at any time be or have been members of the Institute or to any persons through them, provided, that nothing herein contained shall prevent payment in good faith of remuneration in return for any service rendered to the institute.
- Upon the dissolution of the Institute, there shall remain after the satisfaction of the debts and liabilities, any property whatsoever, the same shall not be paid or distributed among the members of the Institute but shall be distributed to another charitable organization registered with the state or federal government.
