ARTICLE III PURPOSE

- (1) The said organization is formed exclusively for charitable, educational, and scientific purposes within the meaning of IRC Section 501(c)(3), or corresponding section of any future tax code;
- (2) To have and exercise all rights and powers conferred on nonprofit corporations under the laws of Florida, or which may hereafter be conferred, including the power to contract, rent, buy, or sell personal or real property;
- (3) Notwithstanding any of the above statements of purposes and powers, this corporation shall not engage in any activities or exercise any powers that are not within the furtherance of the primary purpose of this corporation;
- (4) No part of the net earnings of the corporation shall inure the benefit of, or be distributed to, its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable contribution for services rendered and make payments and distributions in furtherance of the purposes set forth in Article Three hereof.
- (5) No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office;
- (6) Upon dissolution of this corporation, assets remaining shall be distributed to one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal, or to a state or local government, for a public purpose Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located as said court shall determine, which are organized and operated exclusively for such purposes.
