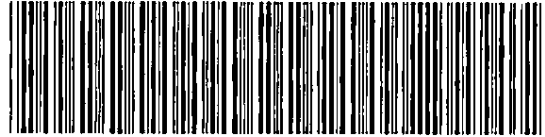

**ARTICLES OF INCORPORATION
OF
DWYERFIRE GOLDSTAR FOUNDATION, INC.**

(A Florida Not For Profit Corporation)

**ARTICLE I
NAME**

The name of this corporation shall be DWYERFIRE GOLDSTAR Foundation, Inc. (hereinafter called the "Corporation").

**ARTICLE II
PRINCIPAL OFFICE AND/OR MAILING ADDRESS**

The street address of the initial principal office and the mailing address of the Corporation is 115 S 39th St. Mexico Beach, Florida 32456.

**ARTICLE III
PURPOSE**

The Corporation is organized and shall be operated exclusively for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, as it may be amended ("Code"). In furtherance of these purposes, the Corporation shall empower Gold Star Children by providing mentorship, guidance, and support through sports and fitness.

**ARTICLE IV
MEMBERSHIP**

The Corporation shall have no members.

**ARTICLE V
REGISTERED OFFICE AND AGENT**

**ARTICLE VI
BOARD OF DIRECTORS**

The manner of election of the Board of Directors shall be as provided in the Bylaws of the Corporation.

**ARTICLE VII

ARTICLE VIII **LIMITATIONS**

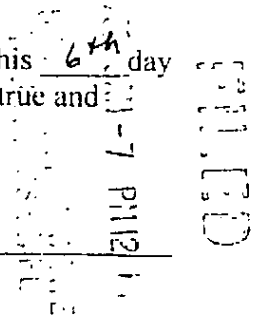
No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of any of its purposes. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting, to influence legislation (except as otherwise provided in subsection (h) of section 501 of the Code), and the Corporation shall not participate or intervene in (including the publishing or distributing of statements) any, political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Code (or the corresponding provision of any future United States Internal Revenue Law), or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Code (or the corresponding provision of any future United States Internal Revenue Law).

ARTICLE IX **DISSOLUTION**

Upon dissolution, after payment of all valid debts of the Corporation and necessary expenses thereof, or provision for same, all the remaining assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Code, or to U.S. federal, state or local governments for a public purpose.
