This corporation is founded exclusively for charitable purposes within the meaning of the IRS Code Sec 501(c)(3); namely: To provide emotional and spiritual support for South Florida patients and their families. It will provide Jewish Ministry, visitations, rituals, customs, prayers, spiritual counseling and education to patients, families and the general public concerning end of life care. This corporation will coordinate with hospices, hospitals, rehabilitation centers and other institutions to ensure that Jewish patients are treated as required by Jewish Law and tradition. It will provide guidance concerning the ethical perspectives offered by Jewish Law on complex issues related to medical treatments and end of life care. It particular it will attend to patients who are awaiting, undergoing and recovering from organ transplants. Transplant recipients often experience difficult spiritual and emotional transitions, which may lead to ambivalent feelings; such as, elation mixed with depression, gratitude linked with survivor guilt, increased strength linked with broken-ness and hope linked with deep anxiety. Utilizing up to date interventions and traditional Jewish spiritual insights, this corporation will provide individual, group, couples and family counseling to assist transplant recipients resolve their issues and experience healing, faith and joy. This corporation will, at the sole discretion of the Directors, provide grants to assist families and patients in need. It will strive to ensure that those who have passed on receive Jewish funeral services and burial as required by Jewish Law and tradition. It will carry out any additional activities that are seen by the directors to be in furtherance of the well-being of persons, families, Jewish communities and humanity in general.

This corporation shall not, except in an insubstantial way, engage in any activities or exercise any powers that are not in furtherance of the above-mentioned charitable religious purposes. It will not attempt to influence legislation in any way or participate in political campaigns of any sort. No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its directors, officers or any private person except that this corporation will be empowered to pay reasonable compensation for services rendered, for work done, resources purchased or properties acquired that are seen by the directors to be in furtherance of its exempt purposes. This corporation will be empowered to rent or buy personal or real property, in order to provide a suitable location for its activities.

Upon the filing of these articles of incorporation with the Secretary of State, the Directors will be empowered to adopt bylaws and other related documents, to

appoint corporate officers and to authorize them to open bank accounts, file forms with government agencies and undertake any other action required for the operation of this corporation. Replies sent from emails belonging to directors shall be seen as written signed consent and the equivalent of a vote cast at a meeting of the directors. The Directors are hereby given the authority, both individually or in pairs, to open accounts and serve as signatories on behalf of this corporation in any banks, branches or financial institutions that the directors shall deem appropriate.

In the event of this corporation's dissolution, the directors will —after clearing all debts and liabilities— distribute any remaining funds or assets to other charitable organizations recognized by the IRS under section 501(c)(3) that have similar purposes.
