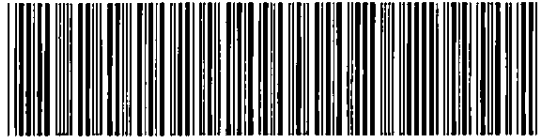

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, F.S. 617.0202, hereby adopt(s) the following articles of incorporation:

ARTICLE I:

NAME

The name of the corporation shall be:

PURPOSE(S)

The specific purpose (s) for which the organization is established is to provide equal opportunity by providing technical / educational assistance to the poor, deprived and unprivileged classes of society.

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including the collecting and distribution of charity, for such purposes, as to advance education and making of distributions to organizations, that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of the any future federal tax code.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code


